GUIDANCE ON THE ACCOUNTING AND DISCLOSURE OF GOVERNMENT VEHICLE TRANSACTIONS

PURPOSE

1. To inform accounting authorities and chief financial officers of **public and trading entities** of the following:
 - 1.1 The retraction of PT Circular 15 / 2011 dated 5 May 2011 regarding "ANNUAL FINANCIAL STATEMENT 2010/11: GUIDANCE ON THE ACCOUNTING AND DISCLOSURE OF GOVERNMENT VEHICLE TRANSACTIONS"; and
 - 1.2 The applicable GRAP/GAAP reporting frameworks for entities.

BACKGROUND

2. PT Circular 15 / 2011 was issued to provide clarity on the accounting and disclosure requirements of GG vehicle transactions by departments and entities.
3. After discussion with the Auditor – General of South Africa (AGSA) it was noted that PT Circular 15 of 2011 was in conflict with the National Treasury's Accounting framework, hence the retraction.

REQUIRED ACTIONS

4. Public entities must report GG vehicle transactions in terms of the applicable standards of accounting as contained in Directive 5, which is updated annually by the Accounting Standards Board.
5. Trading entities must report GG vehicle transactions in terms of the applicable GAAP standards of accounting.
