ACCOUNTING STANDARDS BOARD (ASB) – INVITATION TO COMMENT ON THE PROPOSED TRANSITIONAL PROVISIONS FOR THE INITIAL ADOPTION OF THE STANDARDS OF GRAP (EXPOSURE DRAFT 85)

Purpose

1. The purpose of this circular is to obtain comments in writing on the exposure draft of the Boards proposed transitional provisions for the initial adoption of the Standards of GRAP on Segment Reporting (GRAP 18), Transfer of Functions Between Entities Under Common Control (GRAP 105), Transfer of Functions Between Entities Not Under Common Control (GRAP 106) and Mergers (GRAP 107).


Background

2. The Board approved GRAP 105, 106 and 107 in November 2010, and approved GRAP 18 (which replaces the Standard issued in 2005) in February 2011.
3. In terms of Section 89(1)(c) of the PFMA, the Board will recommend an implementation date for GRAP 18, 105, 106 and 107 to the Minister of Finance.
4. The proposed effective date for GRAP 18 will be 01 April 2013 for public entities, constitutional institutions, high capacity municipalities, Parliament and the Provincial Legislatures, and 01 April 2014 for medium and low capacity municipalities.
5. An effective date of 01 April 2013 will be proposed for GRAP 105, 106, and 107 for all entities required to comply with GRAP.
6. The Board needs to develop transitional provisions to assist entities with the initial adoption of these Standards of GRAP.

Action required

8. The Board welcomes any comments on the principles of the exposure draft, whether supportive or critical.
9. Respondents are also invited to provide detailed comment identifying the specific paragraphs to which it relates, explaining the issue and suggesting alternative wording, with supportive reasons, where this is appropriate.
