2011/12 MTREF LOCAL GOVERNMENT ALLOCATIONS AND GOING FORWARD

1. Purpose

1.1 The purpose of this circular is to advise all of the Western Cape municipalities about the process which will be followed and the method that will be applied by the Provincial Treasury in gazetting the Local Government Allocations for 2011/12 MTREF and beyond.

2. Background

- 2.1 Local Government Allocations made by the provincial departments are published every financial year, through a provincial gazette, and Provincial Treasury must check whether processes have been followed and test budgeting methods applied in finalising such allocations.
- 2.2 These processes and methods must be the basis for decision making by the provincial departments when allocating funds and it must be ensured that the financial resources that are allocated are efficiently utilised by the end of each financial years.

3. Discussion

- 3.1 Provincial Treasury has a responsibility of financial resource allocation and guidance of expenditures in the municipal sphere and a standardized process of finalising allocations for the purpose of publication (gazette) has been established. The process seeks to ensure that all allocations are made to municipalities on their consent and that municipalities have sound plans on how to spend the allocations made. See attached **Annexure A**.
- 3.2 This process has been informed by an observation that some of the municipalities fail to spend the entire allocated grant funding by provincial departments while some municipalities have shown the capacity to spend all the allocated grant funding. In the past financial years, funds have been allocated to municipalities without looking at performance expenditure trends of a specific provincial grant.
- 3.3 Provincial Treasury wants to ensure that Local Government Allocations are made based on past performance expenditure trends on each of the provincial grants, per municipality, to ensure that funding is shifted from municipalities that are not fully spending their grants and allocated to those which have demonstrated an appetite and capacity to spend. The past performance on expenditure will be looked at in conjunction with the demand of funding by municipalities.
- 3.4 However, it must be noted that allocations will be made based on the available financial resource envelope that is always set aside for a specific grant by each of the provincial departments. Municipalities are encouraged to build a business case on

each of the provincial grants looking at the demand.

- 3.5 In processing the 2011/12 MTREF Local Government Allocations and beyond, transferring provincial departments will be engaged to ensure that allocations are made based on the processes and methods mentioned above.
- 3.6 For the benefit of the above process and municipalities, provincial departments will be encouraged to make the indicative allocations available to municipalities by the end of January each year to ensure that municipalities include the allocations in the draft budgets.
