# REPORTING ON THE PCI SYSTEM IN RESPECT OF THE NEW PREFERENTIAL PROCUREMENT REGULATIONS 2011.

#### PURPOSE

1.1. The purpose of this communiqué is to inform municipalities on the current status when reporting on the Procurement Contract Information system on bids awarded above the threshold value of R100 000.

#### 2. BACKGROUND

- 2.1. The National Treasury indicated by means of an e-mail correspondence, that the PCI system is being revamped to accommodate/ align with the new requirements of the Preferential Procurement Regulations, 2011 and that municipalities needs to half the capturing process on the PCI system until further instructions has been provided.
- 2.2. The National Treasury in its response alluded that it is embarking on a process of upgrading the PCI system to inter alia make provisions for the amendments emanating from the revised Preferential Procurement Regulations, 2011 which took effect on the 07 December 2011.

#### 3. REQUEST

## 3.1. The Provincial Treasury hereby request that:

- a. The Accounting Officer must ensure that the content of this Circular is brought to the attention of all the relevant officials within the institution.
- b. Municipalities are to continue with the reporting on bids awarded above R100 000 to the Provincial Treasury, for the purpose of transparency as per Provincial Treasury Circular 26 of 2011.

c. For the interim, municipalities are required to utilised the attached templates (see annexure **B1 & B2**). These templates will be forwarded electronically to all municipalities.

#### Please note:

- Annexure B1 is to be utilised for the purpose of reporting on bids (above R100 000) awarded up until the 06 December 2011, applying the old Preferential Procurement Regulations, 2001; and
- Annexure B2 is to be utilised for the purpose of reporting on bids (above R100 000) as at 07 December 2011, applying the revised Preferential Procurement Regulations, 2011.
