ESTABLISHING A PROVINCIAL TREASURY HELPDESK

MASTER RECORDS OFFICIAL: FINANCIAL MANAGEMENT

PURPOSE

To inform all provincial departments and public entities about the establishment of a Provincial Treasury Financial Governance Helpdesk. This functionality will operate from 1 March 2012.

BACKGROUND

Provincial Treasury (PT) has continuously assisted and guided provincial departments and entities on an informal ad-hoc basis. PT has identified the need for a formalised structured approach to improve the quality and standard of the services that are rendered to departments and entities.

Section 18 (2)(e) of the PFMA (Act 1 of 1999), states that a PT may assist provincial departments and public entities in building their capacity for the efficient, effective and transparent financial management.

In this regard PT has implemented a helpdesk email facility (pthelpme@pgwc.gov.za). This will provide departments and entities with advice and guidance on financial governance issues. It will also provide PT with a mechanism to analyse and monitor queries received and resolved.

ACTION REQUIRED

Departments and public entities are required to lodge queries on the PT Financial Governance Helpdesk. The requirements are set out in the attached PT Helpdesk Framework.
