- 1. The purpose of this circular is to inform all personnel within the Provincial Government Western Cape that in accordance with section 7 (2) of the Public Finance Management Act, 1999 (Act 1 of 1999) as amended, Nedbank will remain the official banker of the Provincial Government of the Western Cape for a further period of five (5) years as from 1 April 2012 to 31 March 2017.
- 2. The bidding process was concluded on 1 February 2012 and the successful bidder Nedbank was informed on 2 February 2012.
