SUBMISSION OF SERVICE DELIVERY AND BUDGET IMPLEMENTATION PLANS (SDBIPs)

The purpose of this circular is to remind municipalities about the submission of Service Delivery and Budget Implementation Plans (SDBIPs) in terms of the Municipal Finance Management Act (Act 53 of 2003).

In terms of section 69(3) of the MFMA, the Accounting Officer must no later than 14 days after the approval of an annual budget submit to the Mayor a draft SDBIP for the budget year and drafts of the annual performance agreements as required in terms of section 57(1)(b) of the Municipal Systems Act (Act 32 of 2000) for the Municipal Manager and all senior managers.

Subsequent to this, section 53 of the MFMA requires that the Executive Mayor of a municipality approves the municipality's SDBIP within 28 days after the approval of the budget. In terms of section 19 of the Municipal Budget and Reporting Regulations the Municipal Manager must in accordance with section 21A of the Municipal Systems Act make public the approved Service Delivery and Budget Implementation plan within ten working days after the Mayor has approved the plan in terms of section 53(1)(c)(ii) of the Act.

Section 20(2) of the regulations further states that the municipal manager must submit to the National Treasury and the relevant provincial treasury, in both printed and electronic form -

- (a) The supporting documentation within ten working days after the municipal council has approved the annual budget;
- (b) The approved service delivery and budget implementation plan within ten working days after the mayor has approved the plan; and
- (c) Any other information as may be required by the National Treasury.

Municipal Managers are requested to submit the SDBIPs to Provincial Treasury as soon as possible but not later than 12 July 2012.
