The following recommendations as per page 9 of the report dated 14 January 2021 by CTS heritage to be included:

1. Power Line Corridor Alternative Alignments 3 and 4 (Oya to Kappa) are preferred in terms of impacts to heritage and there is no objection on heritage grounds to the proposed substations.
2. No mitigation is required prior to construction operations commencing.

3. The recommended buffer areas and no-go areas identified in Table 4 of the HIA must inform the final alignment and must be implemented during the construction phase.
4. During the construction phase all excavations must be monitored for fossil remains by the responsible Environmental Control Officer (ECO) using the HWC Chance Fossil Finds Procedure. Should substantial fossil remains such as vertebrate bones and teeth, petrified wood, plant-rich fossil lenses or dense fossil burrow assemblages be exposed during construction, the responsible ECO should safeguard these, preferably in situ, and alert HWC in the Western Cape so that appropriate action can be taken by a professional palaeontologist,
5. Should any evidence of archaeological sites or remains (e.g. remnants of stone-made structures, indigenous ceramics, bones, stone artefacts, ostrich eggshell fragments, charcoal and ash concentrations), fossils or other categories of heritage resources be found during the proposed development, HWC in the Western Cape must be alerted.
6. If unmarked human burials are uncovered in the Western Cape, HWC must be alerted immediately as per section 36(6) of the NHRA. A professional archaeologist must be contracted as soon as possible to inspect the findings. A Phase 2 rescue excavation operation may be required subject to permits issued by HWC
