10.1 Heritage Information Management Services

CSc presented a verbal report.

Among other things, the following was noted by Council:

- Technical challenges to integration are posed by the different platforms for HIMS and SAHRIS, but these can be overcome.
- The HIMS online permit application process is still being tested.
- The final report from SAHRA will be tabled at Council by the CEO once it is available.
- SAHRA is preparing Regulations in terms of S.39 of the NHRA in order to regulate reporting of heritage resources and the ceding of databases from HRAs, organs of state and state-supported bodies of SAHRA. The draft will be circulated for comment next year.

11.1 Draft HWC Annual Performance Plan 2018/2019

MD presented the report, which was noted by Council.

11.2 Review of internal work processes, to achieve efficiency and effectiveness

CSn presented his report and Council noted the report.

Among other things, the following was noted by Council:

 The review of internal processes was requested by Exco in order to enhance management of heritage resources. HOMS functions extremely well in terms of effort and abilities, but there are improvements that can be made in several areas to reduce blockages and improve efficiency.

- The constraints to adequate remuneration, working conditions and capacity-building, and consequent low morale of HWC staff, have long been acknowledged by Council, senior management and the MEC. Despite various embedded impediments, more action can be taken to alleviate the situation.
- The comprehensive recommendations under Section 4 of Mr Snelling's report are endorsed in principle. Some remedies can be implemented immediately and others as soon as possible.

DECISION

- 1. The report was adopted with thanks and appreciation for Mr Snelling's voluntary time spent on producing a substantial and useful analysis of problems and suggested recommendations.
- 2. The recommendations must be assessed and implemented as appropriate, with reports back by management as to progress.

11.3 Progress on implementing Council resolution to increase preparation time by Committee members

NV presented her report, which was noted by the Council.

DECISION

The Council approved the revised remuneration for reading hours as follows:

BELCom - maximum of 5 hours
 Appeals- maximum of 3 hours
 APM- maximum of 3 hours
 IGIC- maximum of 5 hours
 IACom - maximum of 5 hours

The changes are to be implemented on a date to be determined by the CEO (in terms of budgeting) or by the 1st of April 2018, whichever is sooner.

11.4 Publication of Policy on Public Consultation for comment

MD presented his report, which was noted by Council.

Among other things, the following was noted by Council:

- The Draft Policy was presented at a workshop at HWC and comments received must be integrated into a new draft.
- In the light of emergency applications, such as under City of Cape Town drought conditions, minimum public consultation, when heritage is impacted on, must still be conducted as there is no provision in the NHRA to exempt any state body from public participation processes.
- Section 34 applications for minor works / un-heritage-worthy contexts pose a problem, and clarification is needed on what defines "legitimate interest".
- Enabling HWC to apply discretion under certain circumstances should be considered and included in the new draft.

DECISION

The Council approved the Draft Policy, subject to the S.34 requirements being redrafted and included before it is advertised for comment.

12. Standing Items

12.1 CEO's Report

MD presented his report. Council noted the CEO's report.

Among other things the following was discussed:

- World Heritage Site nominations are progressing for Early Cape Farmsteads (ICMP due to be tabled at IACom) and Origins of Modern Humans (service provider appointment).
- An offer has been made to an applicant for the post of Heritage Officer to start on 1 January 2018.
- New members of IACom have been appointed but an experienced architect is still needed (see item 12.6). Other appointments are noted in the relevant committee reports.
- Court cases pending include the Philippi Horticultural Area, the Buitengracht Street Development and Baboon Point.

12.5 Report and Feedback on BELCom

GJ presented the report on behalf of KDS. This report was noted by Council.

Among other things the following was discussed:

- The committee lacks a social historian.
- A table of appeals cases (most arise from BELCom decisions) and summary analysis to be prepared by PM and discussed with the committee and practitioners.
- Following a committee site inspection, heritage application and design guidelines for Elim must be prepared (and may be supported by a Heritage Agreement between HWC and the Church).
- The inter-committee discussion on grading of Grade III buildings and buildings of the 1930s must take place in the New Year.

DECISION

The CEO to expedite the appointment of an additional member (social historian) to BELCom.

The operational recommendations in the report are to be urgently assessed and implemented as appropriate and feasible.

12.6 Report and Feedback on IACom

CSn presented his report, which was noted by the Council.

Among other things the following was discussed:

- Several committee members resigned for various reasons. Mr Dave Saunders and Mr Tizzie Mangiagalli have been appointed, and an APM member will replace Dr Walker in January, but the committee lacks a senior heritage architect.
- The deteriorating relationship between HWC and DEA&DP, whereby heritage management recommendations made by IACom have been disregarded by DEA&DP, is of serious concern.

DECISION

The CEO will expedite the appointment of an additional member (architect with heritage experience) to IACom.

The responsibility of DEA&DP to comply with S.38 (8) provisions must be strongly reiterated, and supported by senior counsel opinion, and the relevant section of the Standard Operating Procedure between HWC and DEA&DP to be reviewed.

12.7 Report and Feedback on APMCom

AM presented her report, which was noted by Council.

DECISION

The Council approved the appointment of Dr Lita Webley to serve on IACom.

12.8 Report and Feedback on Appeals Committee

AM presented CSm's report, which was noted by Council.

Among other things the following was discussed:

- The standard clause in Records of Decisions and Permits does not reflect current practice regarding notification of decisions and conditions.
- Committees need to articulate the reasons for making a grading decision for the record and in their minutes.
- Progress with public access to decisions of committees and HOMS on the website, and digital recording of committee meetings (now in place).
- Inconsistencies between HWC Policy and MEC regulations regarding appeals, leading to issues around time frames.
- Alignment of PAJA requirements and HWC Draft Policy regarding public participation, and the communication of interim requirements to applicants and the public, acknowledging that the method and extent of public participation in decision-making depends on circumstances.

DECISION

The standard clauses in Records of Decision / Permits are to be amended to (a) clarify responsibility of notification of interested parties and (b) state the right to ask for reasons for decisions.

12.9 Report and Feedback from IGICom

SM presented his report and tabled a supplement referring to the meeting of 17 November 2017, which Council noted.

Among other things the following was discussed:

- Mr Tizzie Mangiagalli has been appointed to the committee.
- Three heritage resources have been graded Grade IIIA and two PHS nominations are in progress (Green Point Common and Rocklands City Hall).
- Hostel 33 Lwandle, part of the Migrant Labour Museum, Strand, has been endorsed as a PHS. See also items 12.12.3-6.
- The committee has endorsed the approach by Perception Planning heritage consultants, to compile a simplified register of heritage resources for priority areas in the George Municipality.
- It is further recommended that George Municipality should supply a progress report regarding updates to the Heritage Survey and Inventory and its integration into Spatial Development Plans, and is strongly reminded to submit applications related to buildings over 60 years old to HWC for approval.
- A revised heritage resources register for priority areas must be submitted to HWC for approval.

DECISION

The revised Provincial Heritage Site nomination application form is approved.

Council will approve IGIC recommendations regarding proposed PHS nominations at the next meeting.

Among other things the following was discussed:

- With reference to S.27 of the NHRA, HWC Council is required to either approve or decline a nomination for PHS status (Grade II) following a recommendation by IGIC.
- Council noted the representations made by the interested and affected parties. It
 was also noted that certain of the representations were made in respect of the
 proposed development. However, in this case, consideration of the S.38
 development application process is a completely separate matter from
 consideration of the appropriate level of heritage management of the as yet
 undeveloped property.
- Following the original PHS nomination, lengthy submissions and deliberations, an opportunity for the nominators to submit further motivations was offered, and a site inspection by the IGIC took place, before the decision by IGIC was reached.

DECISION

The Council approves the findings of IGIC and the grading of Grade IIIA. The nomination for PHS status is not approved.

13.1 Amendment of Delegations

Among other things the following was discussed:

- Council and the CEO requested a review of delegations in terms of improving efficiency and effectiveness of HWC operations.
- As per the review of the internal work processes submitted by CSn; In terms of
 existing delegations, HOMS can only take decisions where the matter is not
 controversial and there are no objections. This leads to unnecessary burdens on
 staff and committees in the preparation and hearing of such cases.

- Delays in processing applications are caused when a chair for HOMS is not available.
- No consultation is required for NID decisions.
- There is no provision within S.38 of the NHRA for the issuing of an emergency permit, even to state organs.

DECISION

Council approves the delegations to HOMS:

- a) To consider heritage applications that have objections which are deemed not heritage-related or are frivolous.
- b) The Assistant Director to chair HOMS in the absence of the CEO or Deputy Director or as requested.

The delegation to the CEO for Section 27 annexed to the report is to be redrafted and Section 38 removed. The revised document is to be circulated to Council for comment. The final document will be signed by the chairperson.

13.2 Publication of Regulations in terms of Sections 30 & 31 of the NHRA for comment

PM presented her report, which was noted by Council.

Among other things the following was discussed:

- The S.30 and S.31 Regulations enable Local Authorities to enforce the NHRA at local level, once they are competent.
- The establishment of Heritage Areas and Heritage Registers is urgently required to effectively protect and manage heritage resources.
- The draft was presented at a Local Authorities workshop and a programme for awareness and consultation is ongoing.

DECISION

Council resolved to approve the publication of the Draft Regulations in terms of Sections 30 and 31 of the NHRA for comment.
