

# WESTERN CAPE SUPPLIER DATABASE

The Western Cape Supplier Database is an internet software application that allows the 13 departments of the Western Cape to find you and your business in order to meet their specific needs for any project. The Western Cape Government is not allowed to do business with you if you are not registered on the database.

- A registered supplier will be considered a verified supplier, meaning that you meet the minimum requirements to do business with the Western Cape Government.
- You only need to register on the central database once and your details will be available for use by all departments/institutions.
- This eliminates the repetitive submission of the required documentation for each bid/quote lodged at various departments.
- Your registration on the database is free.

## ● Will you get work if you register?

Registration does not guarantee that you will receive work; it only serves as a compulsory requirement to do business with the Western Cape Government and grants you the opportunity to provide your services to government departments.

## ● What do you need to do to register?

All prospective suppliers must submit applications for registration on the database and amendments to supplier profile within the format as prescribed by the Provincial Treasury.
