DRAFT AMENDMENT, 2019**

The Provincial Minister of Finance, in terms of section 81 of the Western Cape Gambling and Racing Act, 1996 (Act 4 of 1996), intends to make the regulations set out in the Schedule.

SCHEDULE**Definition**

1. In these regulations “the Regulations” means the Western Cape Gambling and Racing Regulations (Fees and Costs), 2016, as published under Provincial Notice 97/2016 dated 31 March 2016 and amended by Provincial Notices 81/2017 (dated 24 March 2017) and 45/2018 (dated 26 March 2018).
