MOSSEL BAY MUNICIPALITY**HONOURS BY-LAW**

To provide for Municipal Honours, the conferral thereof, the amendment of conferral of Municipal Honours, and to provide for matters incidental thereto.

PREAMBLE

WHEREAS section 156(5) of the Constitution of the Republic of South Africa, 1996 in general authorizes a municipality to execute any power concerning a matter reasonably necessary for, or incidental to, the effective performance of its functions;

WHEREAS section 156(2) of the Constitution of the Republic of South Africa authorizes a municipality to make by-laws for the effective administration of the matters which it has the right to administer;

WHEREAS it is desirable to take into consideration and recognize persons for exceptional achievements or the rendering of exceptionally meritorious service in the interest of the municipality; and

WHEREAS this needs to be done in an orderly manner;

Be it therefore, enacted by the Council of the Municipality of Mossel Bay.

10. SHORT TITLE AND COMMENCEMENT

1. DEFINITIONS

- (1) In this By-Law, words used in the masculine gender include the feminine, the singular the plural and vice versa,

“The Council” means the Municipal Council of the Mossel Bay Municipality.

“Mossel Bay Municipality” means the means the Municipality of Mossel Bay established by Establishment Notice P.N. 500/2000 in Provincial Gazette 5592 of 22 September 2000 issued in terms of the Local Government: Municipal Structures Act, 1998 (Act 117 of 1998).

“Municipal Manager” means the Municipal Manager of the Municipality.

“Councillor” means a member of the Municipal Council of the Mossel Bay Municipality.

“Employee” means an employee of Mossel Bay Municipality.

2. MUNICIPAL HONOURS

- (1) The following honours may be conferred by the Mossel Bay Municipality:

- (a) freedom of the town of Mossel Bay;
- (b) honorary citizenship of the Mossel Bay Municipality;
- (c) aldermanship;
- (d) a Council commendation certificate;

- (2) The Mayor is the patron of the Municipal Honours as described in terms of this By-Law.

- (3) The Mayor, or any other Councillor may apply in writing to the Municipal Manager, with a full motivation, for the conferral or annulment of Municipal Honours in terms of this By-Law. The Municipal Manager will in turn refer an item to Council for consideration of the request.

3. CONFERRAL OF MUNICIPAL HONOURS

The Mayor, after approval from Council may confer Municipal Honours on any person and may make a posthumous conferral of a municipal honour.

4. ANNULMENT OF CONFERRAL OF MUNICIPAL HONOURS

The Mayor, if approved by Council by way of a majority vote, may annul the conferral of a Municipal Honour if the holder of the honour has performed any action or has behaved in a manner which harmed the interest of the Mossel Bay Municipality, or otherwise has become unworthy of the Municipal Honours concerned.

5. CRITERIA FOR THE BESTOWING OF MUNICIPAL HONOURS WITH REGARD TO FREEDOM OF THE TOWN

- (1) The Freedom of the town of Mossel Bay will be conferred:
 - (a) on a non-resident person or organization, when such person or organization is worthy of such an honour in the opinion of the Council;
 - (b) if approved by Council by way of a majority vote.
- (2) The Freedom of the town of Mossel Bay shall not be conferred on an active politician.
- (3) **The following privileges are awarded to the holder of the Municipal Honours with regard to Freedom of the town:**
 - (a) the provision of a special parking space in the municipal parking area on prior arrangement;
 - (b) the provision of agendas in electronic format if so required;
 - (c) the holder is put on the municipal invitation lists;
 - (d) reserving of a special seat at Council Meetings should a holder so wish;
 - (e) issuing of an Honourary certificate;

6. CRITERIA FOR THE BESTOWING OF MUNICIPAL HONOURS WITH REGARD TO HONOURARY CITIZENSHIP

- (1) Honourary citizenship of the Mossel Bay Municipality will be conferred:
 - (a) on a person of national and/or international stature residing in Mossel Bay for a period of at least 25 years, when such person is worthy of such an honour in the opinion of Council;
 - (b) if approved by Council by way of a majority vote.
- (2) Honourary citizenship will not be conferred on an active politician.

- (3) The following privileges are awarded to the holder of the Municipal Honours with regard to Honourary Citizenship:
- (a) the provision of a special parking space in the municipal parking area on prior arrangement;
 - (b) the provision of agendas in electronic format if so required;
 - (c) the holder is put on the municipal invitation lists;
 - (d) reserving of special seat at Council Meetings should a holder so wish
 - (e) issuing of an Honourary certificate;

7. CRITERIA FOR THE BESTOWING OF MUNICIPAL HONOURS WITH REGARD TO ALDERMANSHIP/ALDERLADYSHIP

- (1) Aldermanship/Alderladyship will be conferred on a serving Councillor of Mossel Bay Municipality as follows:
- (a) Any member of the Municipal Council becomes an Alderman/Alderlady upon commencement of his/her term as Mayor, Deputy Mayor or Speaker of the Council.
 - (b) Any member who obtains a minimum of fifteen (15) points on the following scale:
 - (i) one (1) point for every year service as a councillor at one or more municipalities and it need not be continuous; and
 - (ii) one (1) additional point for every year service as a member of the Mayoral Committee/Executive Committee.
- (2) The following privileges are awarded to Aldermen/Alderwomen:
- (a) the provision of a special parking space in the municipal parking area on prior arrangement;
 - (b) the provision of agendas even after retirement in electronic format if so required;
 - (c) the Alderman/Alderlady is kept on municipal invitation lists;
 - (d) reserving of special seats at Council Meetings should a member so wish;
 - (e) issuing of an Honourary certificate;

- (3) Any current serving Councillor who is of the view that he/she qualifies for Aldermanship/Alderladyship, should notify the Municipal Manager in writing, together with the necessary details to the satisfaction of the Municipal Manager.

The Municipal Manager shall make a recommendation to Council, after having considered all the relevant details.

8. CRITERIA FOR THE BESTOWING OF MUNICIPAL HONOURS WITH REGARD TO COUNCIL'S COMMENDATION CERTIFICATE

- (1) The Council's commendation certificate will be conferred:
- (a) on a resident of Mossel Bay Municipality when such person is worthy of such an honour in the opinion of Council;
 - (b) if approved by Council by way of a majority vote

9. CONFLICT

In the event of an inconsistency between the English, Afrikaans or Xhosa text, the English text shall prevail

10. SHORT TITLE

This By-Law shall be known as the Mossel Bay Municipality Honours By-Law and takes effect on date of publication thereof.

MOSSELBAAI MUNISIPALITEIT**VERORDENING INSAKE UITSONDERLIKE PRESTASIE**

Om voorsiening te maak vir Munisipale Uitsonderlike Prestasie, die toekening daarvan, die wysiging van die toekenning van Munisipale Uitsonderlike Prestasie, en om voorsiening te maak vir aangeleenthede wat daarmee verband hou.

AANHEF

NADEMAAL artikel 156(5) van die Grondwet van die Republiek van Suid-Afrika, 1996 in die algemeen 'n munisipaliteit magtig om enige bevoegdheid uit te oefen met betrekking tot 'n aangeleentheid wat redelikerwys nodig is vir, of verband hou met, die effektiewe verrigting van sy funksies;

NADEMAAL artikel 156(2) van die Grondwet van die Republiek van Suid-Afrika 'n munisipaliteit magtig om verordeninge te maak vir die effektiewe administrasie van die aangeleenthede wat hy die reg het om te administreer;

NADEMAAL dit wenslik is om persone in aanmerking te neem en te erken vir uitsonderlike prestasies of die lewering van buitengewoon verdienstelike diens in die belang van die munisipaliteit; en

NADEMAAL dit op 'n ordelike wyse gedoen moet word;

Word dit dus deur die Raad van die Munisipaliteit van Mosselbaai goedgekeur.

1. DEFINISIES

- (1) In hierdie Verordening, sluit woorde wat in die manlike geslag gebruik word die vroulike, die enkelvoud, die meervoud en omgekeerd, in

“**Die Raad**” beteken die Munisipale Raad van die Mosselbaai Munisipaliteit.

“**Mosselbaai Munisipaliteit**” beteken die Munisipaliteit van Mosselbaai gestig deur Vestigingskennisgewing P.K. 500/2000 in Provinsiale Koerant 5592 van 22 September 2000, uitgereik ingevolge die Wet op Plaaslike Regering: Munisipale Strukture, 1998 (Wet 117 van 1998).

“**Munisipale Bestuurder**” beteken die Munisipale Bestuurder van die Munisipaliteit.

“**Raadslid**” beteken ’n lid van die Munisipale Raad van die Mosselbaai Munisipaliteit.

“**Werknemer**” beteken ’n werknemer van Mosselbaai Munisipaliteit.

2. MUNISIPALE UITSONDERLIKE PRESTASIE

- (1) Die volgende uitsonderlike prestasie kan deur die Mosselbaai Munisipaliteit toegeken word:

- (a) vryheid van die dorp Mosselbaai;
- (b) ere-burgerskap van die Mosselbaai Munisipaliteit;
- (c) raadsheerskap;
- (d) ’n aanwysingsertifikaat van die Raad;

- (2) Die Burgermeester is die beskermheer van die Munisipale Uitsonderlike Prestasie soos beskryf ingevolge hierdie Verordening.

- (3) Die Burgermeester, of enige ander Raadslid, kan skriftelik by die Munisipale Bestuurder aansoek doen, met ’n volle motivering, vir die toekenning of herroeping van Munisipale Uitsonderlike Prestasie ingevolge hierdie Verordening. Die Munisipale Bestuurder sal weer ’n item na die Raad verwys vir oorweging van die versoek.

3. TOEKENNING VAN MUNISIPALE UITSONDERLIKE PRESTASIE

Die Burgermeester, na goedkeuring van die Raad, mag Munisipale Uitsonderlike Prestasie aan enige persoon toeken en mag ’n posthumme toekenning maak van ’n munisipale uitsonderlike prestasie.

4. HERROEPING VAN TOEKENNING VAN MUNISIPALE UITSONDERLIKE PRESTASIE

Die Burgermeester kan, indien deur die Raad by wyse van 'n meerderheidstem goedgekeur, die toekenning van 'n munisipale uitsonderlike prestasie herroep indien die houer van die eer enige aksie gedoen het of hom op 'n wyse gedra het wat die belang van die Mosselbaai Munisipaliteit benadeel het, of andersins onwaardig geword van die betrokke Munisipale Uitsonderlike Prestasie.

5. KRITERIA VIR DIE TOEKENNING VAN MUNISIPALE UITSONDERLIKE PRESTASIE MET BETREKKING TOT VRYHEID VAN DIE DORP

(1) Die Vryheid van die dorp Mosselbaai sal toegeken word:

(a) aan 'n nie-inwonende persoon of organisasie, wanneer sodanige persoon of organisasie volgens die mening van die Raad waardig is van so 'n uitsonderlike prestasie;

(b) indien dit deur die Raad deur middel van 'n meerderheidstem goedgekeur word.

(2) Die vryheid van die dorp Mosselbaai sal nie aan 'n aktiewe politikus toegeken word nie.

(3) **Die volgende voorregte word toegeken aan die houer van die Munisipale Uitsonderlike Prestasie met betrekking tot die Vryheid van die dorp:**

(a) die voorsiening van 'n spesiale parkeerplek in die munisipale

(b) parkeerarea op voorafgaande reëling;

(c) die verskaffing van agendas in elektroniese formaat indien so benodig;

(d) die houer word op die munisipale uitnodigingslyste geplaas;

(e) bespreking van 'n spesiale sitplek by Raadsvergaderings indien 'n houer dit wens;

(f) uitreiking van 'n Uitsonderlike Prestasie sertifikaat.

6. KRITERIA VIR DIE TOEKENNING VAN MUNISIPALE UITSONDERLIKE PRESTASIE MET BETREKKING TOT ERE-BURGERSKAP

(1) Ere-Burgerskap van die Mosselbaai Munisipaliteit sal toegeken word:

(a) aan 'n persoon van nasionale en/of internasionale statuur wat in Mosselbaai woonagtig is vir 'n tydperk van minstens 25 jaar, wanneer sodanige persoon na die mening van die Raad waardig is van so 'n eer;

- (b) indien dit deur die Raad deur middel van 'n meerderheidstem goedgekeur word.
- (2) Ere-Burgerskap sal nie aan 'n aktiewe politikus toegeken word nie.
- (3) **Die volgende voorregte word toegeken aan die houer van die Munisipale Uitsonderlike Prestasie met betrekking tot Ere-Burgerskap:**
- (a) die voorsiening van 'n spesiale parkeerplek in die munisipale parkeerarea op voorafgaande reëling;
 - (b) die verskaffing van agendas in elektroniese formaat indien so benodig;
 - (c) die houer word op die munisipale uitnodigingslyste geplaas;
 - (d) bespreking van 'n spesiale sitplek by Raadsvergaderings indien 'n houer dit wens;
 - (e) uitreiking van 'n Uitsonderlike Prestasie sertifikaat.
- 7. KRITERIA VIR DIE TOEKENNING VAN MUNISIPALE UITSONDERLIKE PRESTASIE MET BETREKKING TOT RAADSHEERSKAP/ RAADSDAMESKAP**
- (1) Raadsheerskap/Raadsdameskap sal soos volg aan 'n dienende Raadslid van Mosselbaai Munisipaliteit toegeken word:
- (a) Enige lid van die Munisipale Raad word 'n Raadsheer/Raadsdame by die aanvang van sy/haar termyn as 'n Burgermeester, **Adjunk Burgermeester** of Speaker van die Raad.
 - (b) Enige lid wat 'n minimum van **vyftien (15) punte** op die volgende skaal behaal:
 - (i) een (1) punt vir elke jaar diens as 'n raadslid by een of meer munisipaliteite en dit hoef nie deurlopend te wees nie; en
 - (ii) een (1) bykomende punt vir elke jaar diens as lid van die Burgermeesterskomitee/Uitvoerende komitee.
- (2) Die volgende voorregte word aan Raadsheer/Raadsdames toegeken:
- (a) die voorsiening van 'n spesiale parkeerplek in die munisipale parkeerarea op voorafgaande reëling;
 - (b) die verskaffing van agendas, ook na aftrede, in elektroniese formaat indien so benodig;
 - (c) die Raadsheer/Raadsdame word op die munisipale uitnodigingslyste gehou;

(d) bespreking van spesiale sitplekke by Raadsvergaderings indien 'n lid dit wens;

(e) uitreiking van 'n Uitsonderlike Prestasie sertifikaat.

- (3) Enige huidig-dienende Raadslid wat van mening is dat hy/sy vir Raadsheerskap/-Raadsdameskap kwalifiseer, moet die Munisipale Bestuurder skriftelik in kennis stel, tesame met die nodige besonderhede tot bevrediging van die Munisipale Bestuurder.

Die Munisipale Bestuurder sal 'n aanbeveling aan die Raad doen, nadat al die tersaaklike besonderhede oorweeg is.

8. KRITERIA VIR DIE TOEKENNING VAN MUNISIPALE UITSONDERLIKE PRESTASIE MET BETREKKING TOT AANWYSINGSERTIFIKAAT

- (1) Die Raad se aanwysingsertifikaat sal toegeken word:

(a) op 'n inwoner van Mosselbaai Munisipaliteit wanneer sodanige persoon na die mening van die Raad waardig is van so 'n eer;

(b) indien dit deur die Raad deur middel van 'n meerderheidstem goedgekeur word.

9. KONFLIK

In die geval van 'n teenstrydigheid tussen die Engelse-, Afrikaanse- of Xhosa-teks, sal die Engelse teks voorrang hê

10. KORT TITEL

Hierdie Verordening sal bekend staan as die Mosselbaai Munisipaliteit Verordening insake Uitsonderlike Prestasie en tree in werking op die datum van publikasie daarvan.
