NOTICE OF DECISION: APPLICATION FOR ENVIRONMENTAL AUTHORISATION IN TERMS OF THE NATIONAL ENVIRONMENTAL MANAGEMENT ACT, 1998 (ACT 107 OF 1998) AND THE ENVIRONMENTAL IMPACT ASSESSMENT REGULATIONS, 2014: THE PROPOSED HOUSING UNITS AND ASSOCIATED INFRASTRUCTURE ON FARM NO. 377 AND PORTION 10 OF FARM NO. 255, RONDEHEUWEL, GREAT BRAK RIVER
