1. I-*Presidential Youth Employment Initiative* iphunyezwa njengephulo le-Basic Education Employment Initiative (BEEI).
2. **Imodeli yenkxaso-mali yeSigaba V**
 - 2.1 **Imodeli yenkxaso-mali yeSigaba V yahlukile kwizigaba zangaphambili. Iprojekthi ngoku iya kuxhaswa ngemali yi-Unemployment Insurance Fund (UIF) noNondyebo kaZwelonke (National Treasury) ngokulandelelanayo.**
 - 2.2 **Inkqubo yenkxaso-mali ye-UIF**

I-*Industrial Development Corporation (IDC)* iya kulawula inkxaso-mali **yamathuba engqesho ayi-14 959** avela kwinkxaso-mali ye-UIF. Isixa esiyi-R80,00 siya kutsalwa kwistayiphendi ekungekatsalwa nto (*gross stipend*) kuso njengentlawulo ye-UIF (ekubhekiswa kuyo kumhlathi 5.3). Izitayiphendi eziyimali eseleyo kwakutsalwa kuzo (*net stipends*), ziya kuhlalulwa ngoomatshini ngqo kwii-akhawunti zebhanki zabancedisi qho ngenyanga. **Izikolo aziyi kuthatha nxaxheba kwiipeyiroli ukwenzela aba bancedisi.**

2.3 Inkqubo yenkxaso-mali kaNondyebo kaZwelonke

Ngamathuba omsebenzi ayi-4 370 ewonke aya kuxhaswa ngemali kusetyenziswa i-*Provincial Equitable Share* nekubhekiswa kuwo kumhlathi 3 no-5.3. ISebe leMfundo leNtshona Koloni (iSebe iWCED) liya kwenza iintlawulo ezenziwa ngoomatshini qho ngenyanga ukwenzela aba bancedisi kwizikolo ezithatha inxaxheba. Iinkxaso-mali ziya kufumaneka kwii-akhawunti zebhanki zezikolo phambi kosuku lokugqibela lenyanga yekhalenda nganye. Izikolo zenza umsebenzi wokulawula i-UIF nokuqinisekisa ukuba izitayiphendi nezibonelelo zedatha (*data allowances*) zihlawulwa ngqo kwii-akhawunti zebhanki zabancedisi.

3. Izitayiphendi ezihlawulwayo neentlawulo ze-UIF

- 3.1 Isitayiphendi emasihlawulwe kubo bonke abancedisi bezemfundo nabancedisi bezikolo jikelele kwiSigaba V se-BEEI, siya kuba yi-**R4 000,00**, ngenyanga **nesiqala ukususela ngowe-01 Juni 2025 yaye siphela ngowe-30 Novemba 2025**. Esi sixa-mali siyuka intlawulo ye-UIF yomqeshi, iprojekthi iya kubonelela ngentlawulo eligalelo lomqeshi (*employer contribution*) ye-1% (R40,00).
- 3.2 Ukongeza apho, intlawulo ye-UIF yomqeshwa ye-1% (R40,00), iya kongezwa, yaye oko kuya kuyenza iyonke intlawulo ye-UIF ibe yi-2% (R80,00). Esi sixa-mali sisonke se-R80,00 siya kuba yinxalenye yeentlawulo ezenziwa ngoomatshini eziya ezikolweni.

5. Iimfuno ezimiselweyo ze-Unemployment Insurance Fund (UIF)

- 5.2 UMthetho i-Unemployment Insurance Act, 2001 (Act 63 of 2001) noMthetho i-Unemployment Insurance Contributions Act, 2002 (Act 4 of 2002), isebenza kubo bonke abancedisi abaqeshwe zizikolo. Abancedisi MABAHLOWULE isixa sentlawulo se-UIF se-1% sexabiso lesitayiphendi sabo qho ngenyanga. **Isikolo nomncedisi ngamnye**

banegalelo lentlawulo ye-1%. Isikolo (njengomqeshi) sinoxanduva lokuhlawula i-1% esiyitsalayo kubancedisi (isahlulo somqeshwa) kunye ne-1% njengoko ibonelelwa ngenkxaso-mali yeprokthi (njengenxalenye yentlawulo eyenziwa ngoomatshini) yesahlulo somqeshi, kwi-UIF **phambi komhla wesi-7 wenyanga nganye.**

6.2 Kucelwa niqaphele ukuba le mihla yeentlawulo ingentla isenokutshintshwa ngokuxhomekeke —

- (a) kwishedyuli evela kuNondyebo wePhondo (*Provincial Treasury*); kunye
- (b) nakumhla wokwenziwa kwentlawulo olawulwa yi-IDC ukwenzela iintlawulo ezenziwa ngqo kwii-akhawunti zebhanki zabancedisi ukulungiselela ukulungelelanisa imihla yeentlawulo nokuqinisekisa ukuba bonke abancedisi bahlawulwa kwangolo suku lufanayo.

6.3 Isikhokelo esimalunga nokulawulwa kweepeyiroli zabancedisi zizikolo siya kunikwa izikolo yi-IDC.

7. Isitayiphendi saqho ngenyanga nesibonelelo sedatha – ISigaba V

7.1 Umncedisi ngamnye uya kufumana isitayiphendi esele kuxhuzulwe kuso esiyi-R 3 960,00 qho ngenyanga. Ukongeza apho isibonelelo sedatha se-R30,00 siya kubonelelwa ithuba leenyanga ezintandathu (ukususela ngoJuni kude kube ngoNovemba 2025). Injongo yesi sibonelelo kukuba abancedisi babenako ukufikelela kumaqonga (*platforms*) oqeqesho nokuba bazigqibe iimvavanyo emva kweyure zesikolo.

7.2 **Okubalulekileyo:** Isibonelelo sedatha masihlawulwe kunye nesitayiphendi saqho ngenyanga ukuqinisekisa ukufikelela kwabo kumaqonga oqeqesho (*training platforms*) nezibonelelo kwangexesha, njengoko kucacisiwe kumhlathi 5.3.

7.3 Abancedisi baya kubanelungelo lesibonelelo sedatha sakanye qwaba kuphela ngenyanga.

7.4 Abancedisi mabakuvume ukuzifumana naziphi na izibonelelo ezikhethekileyo. Iikhontrolishithi (*control sheets*) ezilolu hlobo maziyixele ngokucacileyo injongo yesibonelelo esikhethekileyo, iinkcukacha zomncedisi ngamnye (igama, ifani, inombolo

yesazisi (ID)/yepasipothi), zalowo kuhlululwe kuye isibonelelo kunye nesignitsha njengobungqina bokuvuma ukufunyanwa kwesibonelelo. Inqununu mayikusayinele oko kwikhontrolishithi njengobungqina bokugqibela besigunyaziso sokuba zenziwe iintlawulo zabancedisi.

8. Iintlawulo ii-Pro rata stipend payments

- 8.1 Makuqatshelwe ukuba nawuphi na umncedisi oqala enyangeni okanye olahlayo emsebenzini ngethuba lenyanga kuphela, ukufanele ukufumana isitayipendi esingumlinganiselo welo thuba alisebenzileyo (*pro-rate stipend payment*). I-ofisi yepojekthi yeSebe iWCED, iya kuphonononga idatha yokuqeshwa nokulahla emsebenzini kwabancedisi njengoko ifakwa qho ngenyanga kwi-Finance and Personnel Management System. Kubalulekile ukuba izikolo zifake imihla yokuqeshwa nokulahla emsebenzini kwabancedisi **ngokuchanekileyo nangexesha**. Iinkqubo zeentlawulo zesitayipendi zezikolo zisuselwa ngokumandla kumhla wokuqeshwa nokulahla emsebenzini njengoko ufakiwe kwikhompyutha zizikolo kwi-Finance and Personnel Management System.
- 8.2 Zonke iintlawulo ii-pro rata stipend payments ezingumlinganiselo welo thuba umqeshwa alisebenzileyo zihlawulelwa **iintsuku zekhalenda** yaye ingezizo iintsuku zesikolo. Umzekelo ngulo: umncedisi olahlayo enkonzweni enyangeni, uya kufumana intlawulo engumlinganiselo welo thuba alisebenzileyo ngeentsuku zekhalenda azisebenzileyo ngenyanga yokulahla emsebenzini. Umncedisi onemvumelwano eqala ngoMvulo umhla we-09 Juni 2025, uya kufumana intlawulo yethuba alisebenzileyo ngoJuni **yeentsuku zekhalenda** eziyi-22 (09 ukuya kwi-30 Juni 2025).

- 8.4 Izikolo mazenze amalungiselelo ayimfuneko ukutsala iimali eziyimfuneko zeentlawulo ezingumlinganiselo welo thuba lisetyenziweyo (ezimiselwe kumhlathi 8.3) ukulungiselela nakuphi na **ukungabikho** kwabancedisi okurekhodiweyo esikolweni (o.k.t. ikhefu elingahlawulelwayo), ezingqinelaniswe neemeko zenkonzo yengqesho njengoko zimiselwe kwimvumelwano yezengqesho. Nayiphi na intlawulo engaphezu kwemfuneko (over-payments) okanye iimali ezigcinwe sisikolo, zimele ukubuyiselwa kwiSebe iWCED zingadlulanga iintsuku ezisixhenxe emva kwempelanyanga nganye. Kucelwa kuthunyelwe nge-imeyili ubungqina bentlawulo ezilolu hlobo kumququzeleli kwisithili we-BEEI ochaphazelekayo.

Uxwebhu i-Memorandum of Understanding for Phase V malusayinwe sisikolo, yaye malubuyiselwe kwi-ofisi yesithili ungadlulanga owe-**15 Meyi 2025** ukwenzela ukuba kuvunywe ukukhutshwa nokusiwa kuso nasiphi na isikolo kwenkxaso-mali ukulungiselela i-BEEI Phase V.
12. ISebe iWCED linqwenela ukunibulela kwakhona ngomsebenzi wenu onzima nangenkxaso yenu ukususela ekuqalisweni kwale projekthi ye-BEEI yaye lithembisa ngokuzibophelela ngokuqhubekekayo ukusebenzisana nezikolo ezithatha inxaxheba ukuqinisekisa ukuba yimpumelelo kweSigaba V.
