1. Ulwabiwo-mali

- 1.1 Ulwabiwo-mali lubalwe ngokungqinelana nemigqaliselo ekwimihlathi 108 ukuya ku-114 ye-National Norms and Standards for School Funding (NNSSF) njengoko ipapashiwe kwiGazethi kaRhulumente No. 29179, ye-31 Agasti 2006.
- 1.2 Ngokomhlathi 110 we-NNSSF, ii-National Table of Targets, ezipapashwe kwiGazethi kaRhulumente No. 51962 of 24 January 2025, zibonisa izixa ezithagethiweyo zango-2026 ngomfundi ngamnye. Isixa esiqingqiweyo sezikolo ezingabizi zifizi siya kuba yi-R1 835.

- 1.3 **linkcukacha zolwabiwo-mali Iwethutyana ngokwemimiselo nemigangatho yolwabiwo-mali (norms and standards (N&S)) zezikolo ezingekho phantsi kwesiqendu 21 zale minyaka**

mithathu izayo yethuba eliqala nge-01 Apreli 2026 ukuya kwi-31 Matshi 2029, ziya fumaneka kwi-CEMIS yaye zinokufunyanwa ngale ndlela ilandelayo:

- (a) Loga kwi-CEMIS.
- (b) Klikha ku-“Proceed” uze ukhethe “Administration” option kwi-menu bar uze uklikhe ku-“Norms and Standards Allocation” uze ukhethe u-“N&S 2026/27”
- (c) Liprinte iphepha elo ukulungiselela iirekhodi zakho.

- 1.4 Ukwenzela injongo zokucwangcisela izikolo, izabelo zolwabiwo-mali lwethutyana zibalwe ngokusebenzisa amanani obhaliso abafundi eSaveyi ye-SNAP yosuku lwe-10 yango-2025.
- 1.5 ISebe leMfundu leNtshona Koloni (WCED) liya kuzijongisisa kwakhona zonke izabelo-mali zezikolo kunye neSaveyi ye-SNAP yosuku lwe-10 yango-2026, ukuqinisekisa ulungelelwano phakathi kwenkxaso-mali namanani obhaliso ukulungiselela unyaka uchaphazelekayo.
- 1.6 **Izabelo zolwabiwo-mali zokugqibela** ziya kupapashwa kwi-CEMIS ungadlulanga owe-15 Apreli 2026.
- 1.7 Apho kufanelekileyo oku, izikolo ezibiza iifizi ziya kufumana inkxaso-mali yokongezelela ukuba isixa-mali esivuniwego seefizi zesikolo zazo sango-2025 kunye nenkxaso-mali ye-N&S ka-2026/27 ngesabelo-mali ngomfundu ngamnye ingaphantsi kwenqanaba lesabelo-mali lezikolo ezingabizi zifizi ngokomlinganiselo womfundu ngamnye. Oku kuya kugqitywa ngako kwakuba kuqinisekisiwe ngeefizi zesikolo zango-2025.

1.8 Iimali ezabiwe ngokwale setyhula mazichithwe ungadlulanga owe-31 Matshi 2027.

2. Ukusetyenziswa kwesabelo-mali

- 2.1 Injongo yesabelo-mali se-N&S kukulungiselela izinto ezinganxulumananga nabasebenzi (*non-personnel items*) kwakunye nemisebenzi yolungiso eqhelekileyo nolondolozo lweziseko zophuhliso zesikolo.
- 2.2 Isabelo-mali se-N&S esisesona sixa sisezantsi, sinokulungiselela iinkcitho emalunga noku kulandelayo:
 - (a) **Izibonelelo eziXhasa ukuFundu nokuFundisa (LTSM)** (makufundwe umhlathi 3.8 (a) ngezantsi ukwenzela olu luulu lwezinto luqukwе phantsi kwe-LTSM).
 - (b) **I-LTSM enxulumene ne-Information Technology (IT) kunye/okanye nezibonelelo zokuphucula ukufunda kusetyenziswa ithekhinolaji (e-Learning)** ekufuneka zibe zezokuthenga i-software, iintlawulo zelayisensi ye-software yezibonelelo zemfundo nemirhumo, ii-aplikheyishini zekhompyutha (*online applications*) nokuhlaziwa kweemvumelwano (*renewal of contracts*) okanye izibonelelo ii-proprietary digital resources zokuphucula ukufunda kusetyenziswa ithekhinolaji (eLearning) nezisebenzisanayo nezixhobo ii-IT hardware (computers, etc.) ezisetyenziswa ngoku ezikolweni.
 - (c) **Ukuthenga kuloo ndawo inesikolo (local purchases)**, okuquka imathiriyeli yokucoca/izixhobo, ii-ovaroli zabacoci nabasebenzi bamabala (ground staff), iimpahla zokuzikhusta ii-personal protective equipment/iimpahla (clothing), izinto

zokubhala (stationery), oomatshini bokufotokopa (photocopier paper), izixhobo zefoni (telephone equipment), ii-intercom systems, neesistim ezizi-closed-circuit television systems.

- (d) **linkonzo zikamasipala/zika-Eskom**
- (e) **Ulondolozo olubalulekileyo Iwemihla ngemihla** Iwezakhiwo zezikolo, amabala nezixhobo zomsebenzi (ulondolozo olwenziwa sisikolo), nemisebenzi yolungiso (repairs) ukukhusela isikolo.
- (f) **Ezinye iindleko zemihla ngemihla** kuqukwya neentlawulo zoomasifundisane, ezeelaisensi ze-TV, ezababoneleli-nkonzo be-intanethi, ezobulungu besikolo kwimibutho yezemfundo, ezokuposa imbalelwano, iintlawulo zokufona, ezokuqeshwa kwezixhobo, iintlawulo zokuphicothwa kweencwadi, iintlawulo zebhanki, ezeenkonzo zomthetho, ezeenkonzo zokhuseleko, ezothutho lukawonke-wonke nezothutho lwabafundi, iinkonzo ze-inshorensi nezokwenza iikopi

2.3 Ingeniso yesikolo esiyenze ngokwaso, njengoko kuchaziwe kumhlathi 6 , mayisetyenziselwe kuqala ukongeza aphi kushota khona kwezi zinto zilapha ngentla phambi kokuba isetyenziselwe ukuhawula izithuba zengqesho zamabhunga olawulo.

2.4 **Kucetyiswa ngokuba ngo-2026/27, izikolo zimele ukusahlula-hlula isabelo ngokwamahlelo ngamahlelo enkcitho (various expenditure categories) ngolu hlubo lulandelayo:**

- (a) I-25% isetyenziselwa ii-odolo ze-LTSM zika-2027 ngamnye umfundu makabe nencwadi yesifundo emiselweyo ngesifundo ngasinye kunye ne-10% emele ukusetyenziselwa izibonelelo zaselayibrari. Istokhwe seencwadi nezibonelelo zaselayibrari mazandiswe (augmented) qho ngonyaka de inani elipheleleyo lee-ayithem (items) libonise owona mgangatho usezantsi wamazwe ngamazwe umiselweyo (minimum international standard) wee-ayithem ezili-10 ngomfundu ngamnye.
- (b) I-15% esetyenziselwa ukuhawula izinto ezithengwa kuloo ndawo inesikolo (local purchases),
- (c) I-10% yezibonelelo ze-LTSM ezinxulumene kunye/okanye neezibonelelo zethekhinoloji ii-digital resources zokomeleza ukufunda ngetekhinoloji (eLearning).
- (d) I-25% isetyenziselwa ii-akhawunti zeenkono zikamasipala/zika-Eskom (**nakuba kunjalo izikolo zifanele ukwenza ibhajethi yepesenti enkulu kunoku ukuba iindlela zenkcitho zazo (expenditure trends) zenza ukuba oku kube yimfuneko**);
- (e) I-20% isetyenziselwa ulondolozo lwsikolo (**i-25% yesi sabelo imele ukusetyenziselwa ulungiso lokukhusela isikolo**).
- (f) I-5% yezinye iindleko zemihla ngemihla.

Ukutshintshwa kwemali (shifting of funds) kwi-WCED 032 form kumele kugqitywe ungadlulanga owe-25 Septemba 2026.

3. Ifom i-WCED 032

- 3.1 libhajethi ze-WCED 032 form, ezifumaneka kwikhompyutha ngokungena kwi-CEMIS, mazizaliswe zize zingeniswe ngekhompyutha ngokungena kwi-CEMIS ukususela ngomhla we-15 ukuya kowe-30 Apreli 2026 yaye kufuneka zisekelwe kulwabiwo-mali lokugqibela, njengoko kukhankanyiwe kumhlathi 1.6. Zonke izikolo ezingekho phantsi kwesiqendu 21 kufuneka, zisahlule isabelo sazo se-N&S sonyaka-mali ophela nge-31 Matshi 2027 sibe **ngamacandelo (categories) amathandathu** kwi-WCED 032 form, angala alandelayo:
- (a) i-LTSM;
 - (b) i-LTSM enxulumene ne-IT/izibonelelo zokomeleza ukufunda ngethekhinoloji ngendlela yokufunda ehlanganisa nethekhinoloji;
 - (c) izinto ezithengwa kuloo ndawo ineskolo (*local purchases*);
 - (d) iiinkonzo zikamasipala/zika-Eskom
 - (e) ulondolozo lwemihla mgemihla; kunye
 - (f) nenkcitho yemihla ngemihla.
- 3.2 Ifom i-WCED 032 iyafumaneka ngekhompyutha kwi-CEMIS yaye kunokufikelelwa kuyo ngolu hlobo lulandelayo:
- (a) Loga kwi-CEMIS uze uklikhe u-“Proceed”.
 - (b) Yiya ku “Administration” kwi-menu bar, khetha u-“School Financial Transaction”, uze ukhethe i-option efanelekileyo.
 - (c) I-WCED 032 form iya kuba sele izaliswe kwangaphambili ukwenzela ukuba kube lula ukuyisebenzisa.
 - (d) Kucelwa nifunde inqaku lolwamkelo (*welcome note*) ze nijonge kwisikhokelo senyathelo nenyathelo esifumanekayo kwisistim.
- 3.3 Kwakugqitywa ukuzaliswa nokungeniswa kwe-WCED 032 form, iSebe i-WCED liya kophonononga iibhajethi. Izikolo ziya kwaziswa ukuba ngaba ii-WCED 032 forms zichanekile na yaye ziya kucelwa ukuba zizingenise kwakhona ii-WCED 032 forms ezihlaziywego. Ukuba akukho ngxelo ifunyenwego nge-08 Meyi 2026, isikolo sinokuthatha ukuba ingcaciso engenisiwego ichanekile.
- 3.4 **Ukungaphumeleli ukungenisa u-WCED 032 form ngomhla omisiwego we-30 Apreli 2026 kuya kubangela ukuba isabelo-mali se-N&S sahlulwe ngokweepesenti ezicetyiswayo ngokomhlathi 2.4.**

3.5 Izikolo ezibiza iifizi

Isabelo-mali esipheleleyo se-N&S (100%) ukwenzela unyaka-mali ophela nge-31 Matshi 2027 masahlulwe sibe ngamacandelo amathandathu (*six categories*) ngokomhlathi 2.2.

3.6 Izikolo ezingabizi zifizi (*No-fee schools*)

Yi-20% yaso sonke isabelo-mali sesikolo se-N&S, emayigcinelwe **inkcitho yemihla ngemihla yokwenziwa komsebenzi enganxulumananga nabasebenzi**. Izikolo ziya kwaziswa ngesi sixa-mali kwileta engesabelo-mali se-N&S. Makukhunjulwe ukuba esi sixa-mali masiqhubi isikolo de kuye kutsho ku-Apreli 2027, apha kuya kufumaneka intlawulo yonyaka-mali olandelayo. Isabelo-mali esiseleyo se-N&S (80%) sonyaka-mali ophela ngowe-31 Matshi 2027 masahlula-hlulwe ngokwamacandelo amathandathu ngokomhlathi 2.2.

3.7 Ukongeza, iintlawulo ezithunyelwa ngekhompyutha (*transfer payments*) kuzo zonke izikolo ezingekho phantsi kwesiqendu 21 zolondolozo (*for maintenance*) neentlawulo zeenkonzo zikamasipala/zika-Eskom (kwezo zikolo zizihlawulela ngokwazo ii-akhawunti zeenkonzo zikamasipala/zika-Eskom), ziya kuhlawulwa ngolu hlobo lulandelayo: i-50% yesixa-mali esibhajethelwe zona ngokwe-WCED 032 form iya kuhlawulwa ngo-Apreli-Meyi 2026, ize i-50% eseleyo ihlawulwe ngo-Oktobha ukuya ku-Novemba 2026.

3.8 Izbonelelo ezincedisa ukufunda nokufundisa (*LTSMS*)

(a) ISebe leMfundu esisiseko (ISebe i-DBE) lizicacisa izibonelelo ezincedisa ukufunda nokufundisa (*LTSMS*) njengazo naziphi na izinto ezixhasa zize zenze kube lula ukufunda nokufundisa kanye ngqo eklasini okanye ekhaya (umsebenzi wesikolo wasekhaya). Zibandakanya oku kulandelayo:

- i. lincwadi zezi-fundo (*textbooks*), iincwadi zokufunda (*readers*), iincwadi zokukhangela izinto-yinto (*reference books*), iincwadi ezimiselweyo (*prescribed books*), ii-atlasi (*atlases*) nezichazi-magama (*ictionaries*)
- ii. liphowusta, iimephu neetshathi zodonga
- iii. Imidlalo efundisa okuthile ii-Educational board games
- iv. Izinto zokufunda zaselayibrari (ezingamabali angeyonyaniso (*fiction*) nezingamabali asusela kwizinto zokwenene (*non-fiction*)), iincwadi zokukhangela izinto-yinto, iiphowusta, iirekhodingi zeevidiyo, ii-Digital Video/ii-Versatile Discs (*DVDs*), ii-Compact Discs (*CDs*), ii-multi-media njl. njl.
- v. I-software yekhompyutha nokulayisenswa kwayo (*Computer software and licensing*)
- vi. Izibonelelo ezisetyenziswa ngootitshala, ngabafundi, eziklasini nakwiilayibrari

(b) Ziyacelwa izikolo zisebenzise isabelo sazo esipheleleyo se-LTSM ukuthenga i-LTSM eya kukwandisa ngamandla ize ikuxhase ukuphunyezwa kwe-Curriculum and Assessment Policy Statement (CAPS) eziklasini zazo. Ngako oko ke ziyakhuthazwa izikolo ukuba zisebenzise isabelo sazo se-LTSM ekuthengeni iincwadi zezi-fundo (*textbooks*) zokongezelela, iincwadi ezimiselwe ukufundwa (*prescribed works*), ii-atlasi (*atlases*) izichazi-magama (*ictionaries*); iincwadi zokwenza imisebenzi

(workbooks); iiphowusta, iimephu neetshathi zodonga, iimidlalo efundisa okuthile (educational board games), izinto zokufunda zaselayibrari (ezingamabali angeyonyaniso (fiction) nezingamabali asusela kwizinto zokwenene (non-fiction), iincwadi zokukhangela izinto-yinto, iiividyo esezirekhodiwe, ii-DVD, ii-CD, ne-software yekhompyutha nezixhobo ze-Consumer Studies and Hospitality Studies nezelebhu yesayensi.

- (c) Inkxaso-mali ye-LTSM nayo imele ukuthathelwa ingqalelo ukwenzela iintlawulo zemirhumo (subscriptions), iiprogram ii-online applications nokuhlaziya kweemvumelwano okanye ezezibonelelo ii-proprietary digital resources. Oku kwenza izikolo zisebenzise isabelo-mali se-LTSM ukuthenga izibonelelo ii-digital resources zokutshintsha inkqubo yokufunda yangaphambili ibe yinkqubo yokufunda yethekhnoloji eyi-digital learning. Ezi zibonelelo zilolu hlobo ziqulethe ii-eBooks kwakunye ne-software yezemfundo (educational software). Ixabiso loku liyafana kungokunje neleencwadi zezifundo engamaphepha aprintiweyo zodidi oluqhelekileyo (traditional hard copy textbooks) linomahluko omncinci/akukho mahluko weendleko kuzo. Makwenziwe amalungiselelo okwenza ukuba izikolo zizibhalisele ezi nkondo/ezi mveliso.
- (d) Ngokuxhomekeke kule miqathango ilandelayo, izikolo zingabela i-LTSM imali encinane ukuba:
- ngamnye umfundsi osesikolweni unencwadi yesifundo kwisifundo ngasinye yaye unako ukufikelela kwizibonelelo ze-LTSM ezizezinye;
 - isikolo besisoloko sisithi qho ngonyaka sabe i-10% yesabelo se-LTSM ekuthengweni kweencwadi nezibonelelo zaselayibrari zokwandisa istokhwe saselayibrari yaye inani lilonke lee-ayithem zaselayibrari kwistokhwe saselayibrari ngoku zii-ayithem ezili-10 ekulelona nani lisezantsi limiselweyo ngokomgangatho wamazwe ngamazwe (minimum international standard of 10 items) ngomfundsi ngamnye; yaye
 - ibhunga lolawulo lithathe isigqibo ngokusesikweni malunga noku tenxa koku. (Esi sigqibo sebhunga lolawulo ngokumalunga nebhajethi, nekufuneka ingeniswe kwintlanganiso yabazali, masicaciswe yaye makunikwe isixa-mali esichithwe kwizibonelelo ze-LTSM, ngomfundsi ngamnye. Esi sigqibo masandlalwe kwintlanganiso yabazali, nokuba ngaba umphathi wesekekethe uyasixhasa okanye akasixhasi.)
- (e) Indlela yokufunyanwa kwe-LTSM:
- Izikolo ezingekho phantsi kwesiqendu 21 mazilandele iinkqubo ezimiselweyo kwisiHlomelo A.
 - Ngokungqinelana nemiyalelo ye-Ofisi kaNondyebo wePhondo, apho kungekho mvumelwano (contract) isebe i-WCED liya kupapasha izicelo ze-LTSM zazo zonke izikolo ezingekho phantsi kwesiqendu 21 kwi-Electronic Procurement System (ePS). Le sistim ivumela ukhuphiswano ngamaxabiso ngokungqinelana nemithetho ebhengezwe ngokwe-Preferential Procurement Policy Framework Act, 2000 (Act 5 of 2000).

- iii. Izikolo mazikhetho zonke izibonelelo ze-LTSM zokongezelela (*top-up LTSM*) kwiikhathalogu zikazweloneke ezivunyiweyo ezikweli ziko lewebhu leSebe leMfundu leNtshona Koloni apha: <http://wcledonline.westerncape.gov.za/index.html>
- iv. ISebe i-WCED lizazisa izikolo qho ngonyaka (ngeesetyhula kunye/okanye neengcaciso ezimfutshane) ngamaxesha amisiweyo oku-odola iincwadi zezifundo zokongezelela zeCAPS kwi-CEMIS.
- v. Ukuba zifuna ukuncediswa ekukhetheni iincwadi nezibonelelo zaselayibrari, kufuneka izikolo ziqhagamshelane noNksz Janine Ontong, uMququzeleli we-EDULIS weeNkonzo zeeLayibrari zeZikolo (School Library Services), kule nombolo yefoni 021 957 9628. Kunokuqhagamshelwana neGosa leeNkonzo zeLayibrari leSikolo (School Library Service Officer adviser) ngokumalunga nokuphuculwa kweenkonzo zeelayibrari zezikolo.

3.9 **linkonzo zikamasipala/zika-Eskom**

- (a) Injongo yesabelo-mali esinikwa izikolo ngokwe-N&S, phakathi kwezinye izinto, kukuhlawula ii-akhawunti zikamasipala/zika-Eskom, ezibandakanya umbane, amanzi, ugutyulo lomphutha (sewage removal), ukuthuthwa kwenkunkuma (iintlawulo zokufumaneka nezosetyenziso), kodwa asikubandakanyi ukuhlawulwa kwerhafu yepropathi. Njengoko kwakunjalo kwixesha elidlulileyo, uRhulumente uya kuyihlawula irhafu yepropathi ebhaliswe ngegama likaRhulumente wePhondo leNtshona Koloni okanye leRiphablikhi yoMzantsi Afrika kwiimeko ezithile.
- (b) Izikolo ezimbalwa zivakalise ukuba azifuni kulawula ii-akhawunti zazo zeenkonzo zikamasipala/zika-Eskom yaye ezi akhawunti zazo ziya kuqhubeka zihlawulwa yi-ofisi yesithili semfundo echaphazelekayo. I-ofisi yesithili semfundo iya kunika isikolo ngasinye iikopi zee-akhawunti zaso qho ngenyanga ngenjongo yokuba sizitshekishe kwaye singqine ukuba ii-akhawunti ezo zichanekile. **Isixa-mali se-WCED 032 simele oko kumelwe ukuhlawulwa liSebe i-WCED yaye esi sixa-mali siya kusetyenziselwa ukuhlawulela iinkonzo zikamasipala/zika-Eskom. Izikolo ziya kumelwa kukuhlawulwa naziphi na iindleko zikamasipala/zika-Eskom ezenziweyo ngaphezu kweso sixa-mali sibhajethelwe oku kwi-WCED 032 form.**
- (c) Izikolo ezingekho phantsi kwesiqendu 21 mazibale imali eziyigcinele iinkonzo zikamasipala/zika-Eskom ngokwenkcitho yazo yangaphambili zidibanise nomyinge wokuhla kwamandla emali (*plus inflation adjustments*), yaye ziyibonise kwifom WCED 032. Esi sixa-mali kunye nemali yolondolozo ziya kuhlawulwa ngaxeshanye kwezo zikolo zavumayo ukuwenza lo msebenzi.
- (d) **Apho singanelanga isabelo-mali se-N&S seenkonzo zikamasipala/zika-Eskom, izikolo zilindeleke ukuba ziyongeze zona ngokwazo imali yesabelo kwiingxowa zazo, apho oku kuyimfuneko.**
- (e) Izikolo kusafuneka, ziwapumeze amanyathelo okonga imali aboniswe kwisiHlomelo B.

- (f) U-Eskom noninzi loomasipala bavakalise ukuba bangazenza iimitha zombane ohlawulelwa ungekasetyenziswa (pre-paid electricity meters) ezikolweni. Oku kuya kwenza izikolo zibe nolawulo olubhetele losetyenziso lombane wazo. Izikolo maziqhagamshelane no-Eskom okanye nomasipala wengingqi, ochaphazelekayo, ukuba zifuna ukuba kufakwe iimitha zombane ezihlawulwa phambi kokuba umbane usetyenziswe.
- (g) Apho kuye kwaqatshelwa ukuba izikolo azizihlawuli ii-akhawunti zazo zikamasipala/zika-Eskom, iSebe i-WCED linelungelo lokuyibamba lingayikhuphi imali eyabelwe ezo zikolo ngokwesabelo se-N&S ukwenzela ukuhlawula ezo zixa-mali zee-akhawunti zingahlawulwanga egameni lesikolo esichaphazelekayo.

- (e) Isabelo-mali se-N&S masingaze sisetyenziselwe ulondolozo Iwezixhobo Iwemihla ngemihla kwiihostele zokuhlala. Olu hlobo lolondolozo maluxhaswe ngemali yeefizi zabafundi yokuhlala ehostele nangeebhasari.
- 3.11 Izikolo mazibonise izabelo-mali ezenzelwe ulondolozo Iwezakhiwo, amabala nezixhobo zokusebenza njengesixa-mali esinye kwi-WCED 032.
- 3.12 Apho izikolo ezingekho phantsi kwesiqendu 21 zithi zigqithise kwisabelo sazo se-N&S, ngenxa yaso nasiphi na isizathu, iSebe i-WCED liya kuyifumana nayiphi na inkcitho engaphezulu ngokuyixhuzula kwisabelo sesikolo se-N&S sonyaka-mali olandelayo. Oku makungajongwa njengokukhuthaza izikolo ukuba zigqithise kwizabelo-mali ze-N&S zazo.
