1. **lingcaciso-magama**

Kulo mgaqo-nkqubo naliphi na igama okanye ibinzina elinikwe intsingiselo, lihlala linaloo ntsingiselo liyinikeyo apha ngezantsi, ngaphandle kokuba umxholo walatha okanye—

“umoni ongumfundi otyholwayo” kuthetha umfundi ekufakwe isimangalo ngakuye;

“umntwana”¹, ngokoMthetho waBantwana i-*Children’s Act, 2005 (Act 38 of 2005)*, kuthetha umntu ongaphantsi kweminyaka yobudala eyi-18;

“impatho-gadalala yabantwana” kuthetha naluphi na uhlobo lokwenzakaliswa ngabom okanye lokungcungcuthekiswa ngabom okwenziwa emntwaneni okubandakanya—

- (a) ukuhlasela umntwana okanye ukumenzakalisa ngabom umntwana nangaluphi na olunye uhlobo;
- (b) ukumxhaphaza ngokwesondo umntwana okanye ukuvumela umntwana ukuba axhatshazwe ngokwesondo;
- (c) ukubhulishwa komntwana ngomnye umntwana;
- (d) isenzo sokumsebenzisa umntwana ngendlela yokumxhaphaza; okanye
- (e) ukumbeka umntwana esichengeni okanye ukumnyanzelisa ukuba abe kwimeko yokuba abone okanye abe kwindawo enokumenzakalisa ngokwasengqondweni okanye ngokweemvakalelo;

“isayikholojisti ekwisekethe (circuit-based psychologist)” kuthetha isayikholojisti eqeshwe liSebe leMfundo leNtshona Koloni (iSebe iWCED), ebhaliswe ngokwe-*Health Professions Act, 1974 (Act 56 of 1974)*, nelawulwa yi-*Health Professions Council of South Africa*;

“unontlalontle okwisekethe (circuit-based social worker)” kuthetha unontlalontle oqeshwe liSebe iWCED obhaliswe ngokwesiqendu 17 se-*Social Service Professions Act, 1978 (Act 110 of 1978)*;

“ukuxhatshazwa ngokwesondo ngenjongo yezoshishino/yezorhwebo (commercial sexual exploitation)” ngokunxulumene nomntwana kuthetha—

- (a) ukuthengwa nokuthengiswa (*procurement*) komntwana ukuba enze imisebenzi yezesondo ngenjongo yokufumana imali, okanye omnye umvuzo kubandakanywa nezenzo zokuthengisa ngomzimba (*prostitution*) okanye izenzo zokwenza nokusasaza imifanekiso yamanyala (*pornography*), kungakhathaliseki nokuba kukho umvuzo ofunyanwayo oyintlawulo okanye okwabelwana ngawo nomthengisi, nomntwana, nomzali/nomgcini/nomnonopheli womntwana, okanye naye nabani na omnye umntu; okanye
- (b) ukushishina/ukurhweba ngomntwana (*trafficking a child*) ukwenzela ukuba asetyenziswe kwimisebenzi yezesondo kubandakanywa nokuthengisa ngomzimba nokwenza nokusasaza imifanekiso yamanyala (*prostitution or pornography*);

“ukohlwaya ngokubetha (*corporal punishment*)”, ngokoMthetho i-South African Schools Act, 1996 (Act 84 of 1996), kuthetha nasiphi na isenzo sangabom esenziwa emntwaneni esimvisa iintlungu okanye ukuphatheka kakubi emzimbeni nokuba asingako, esiquka kodwa singaphelelanga koku—

- (a) ukumbetha (*hitting*), ukumqhwaba (*smacking*), ukumtsweba (*pinching*) okanye ukumkrwempa (*scratching*) ngesandla okanye ngento (*object*),
- (b) ukumkhaba (*kicking*), ukumshukumisa (*shaking*), ukumgibisela (*throwing*), ukumgibisela ngezinto, ukumtshisa, ukumtshisa ngomphunga/ngamanzi ashushu, ukumluma, ukumtsala iinwele, ukumbetha entloko emacaleni, ukubatsala okanye ukubatyhala abantwana;
- (c) ukunyanzela abantwana bahlale ngeendlela ezingafanelekanga nezingathandekiyo (*stay in uncomfortable positions*), ukubaselisa amanzi ngomlomo ngokubanyanzela (*forced ingestion*), ukuhlamba imilomo yabantwana ngesepha, ukubavimba ukutya, ubushushu nendawo yokufaka intloko nokubanyanzela ukuba benze imithambo engangqinelani nekharityhulam efanelekileyo kubo njengabafundi okanye ukubalela okanye ukubaqingqela amathuba okusebenzisa ithoyilethi, kunye
- (d) nazo naziphi na izenzo ezinenjongo yokucekisa, yokunyelisa, yokusongela (*threaten*), yokubangela uloyiko okanye yokuthoba isidima nesithozela somfundi.

“ukungahoywa ngabom” ukulungiselela iinjongo zalo mgaqo-nkqubo kunxulumene nesiqendu 110 se-Children’s Act, 2005 (Act 38 of 2005);

“unontlalontle onyuliweyo” kuthetha unontlalontle oqeshwe ngumbutho onyuliweyo kulo msebenzi ngokoMthetho i-Children’s Act, 2005 (Act 38 of 2005) ukuba enze iinkonzo zokhuseleko lwabantwana, ofana nalo —

- (a) iSebe loPhuhliso loluNtu lePhondo (Provincial Department of Social Development)
- (b) umbutho wokhuseleko lwabantwana obhalisweyo (*a registered child protection organization*), ofana ne-Afrikaanse Christelike Vrouevereniging (ACVV), i-Child Welfare South Africa okanye i-Badisa; okanye
- (c) umasipala;

“ubundlobongela emakhaya (*domestic violence*)”, ngokwe-Domestic Violence Act, 1998 (Act 116 of 1998), kuthetha—

- (a) impatho-gadalala emzimbeni;
- (b) impatho-gadalala ngokuxhatshazwa ngokwesondo;
- (c) impatho-gadalala ngokweemvakalelo, ngamazwi okanye ngokwasengqondweni;
- (d) impatho-gadalala ngokwezemali malunga nokulawulwa kwengeniso, inkcitho ne-akhawunti zebhanki zomntu;
- (e) ukoyikiswa (*intimidation*);
- (f) ukungcungcuthekiswa/ukuhlukunyezwa (*harrassment*);
 - (i) ukuhlukunyezwa/ukungcungcuthekiswa ngokwesondo;
 - (ii) impatho-gadalala ngumntu ozalana naye;
- (g) impatho-gadalala ngokunyashwa kwelungelo lenkolo yomntu;
- (h) ukonakaliswa kwepropati;
- (i) impatho-gadalala kubantu abadala;

- (j) indlela yokuziphatha enyanzelisa omnye umntu enze isenzo esithile;
- (k) indlela yokuziphatha yokulawula okwenziwa ngomnye umntu ukwanelisa iimfuno zakho;
- (l) ukubeka umntwana esichengeni sobundlobongela basemakhaya;
- (m) ukungena —
 - (i) kwindawo yokuhlala esisigxina okanye yethutyana yommangali ngaphandle kwemvume yakhe, apho amaqela achaphazelekayo, engahlali kwindawo efanayo neyakhe okanye
 - (ii) kwindawo yomsebenzi okanye kwindawo yokufunda, ngaphandle kwemvume, apho amaqela achaphazelekayo angasebenzi kwindawo yomsebenzi okanye kwindawo yokufunda efanayo neyakhe; okanye
- (n) nayiphi na enye indlela yokuziphatha eyoyikisayo enyanzelisa ukuba umntu enze isenzo esithile (*intimidating*), eyintsongelo (*threatening*), ehlukumezayo (*abusive*), enyelisayo/ethoba isidima (*degrading*), ethukayo (*offensive*) okanye ethoba isidima (*humiliating nature*) ngakummangali, apho le ndlela yokuziphatha yonakalisa okanye ikhuthaza inkolelo esengqiqweni yokuba ummangali angangaphatheki kakuhle;

“utitshala” ngokoMthetho i-South African Schools Act, 1996 (Act 84 of 1996), kuthetha nawuphi na umntu, kungabandakanywa umntu oqeshwe ngokukodwa ukuba enze imisebenzi eyenziwa emva kweyokufundisa, ofundisa, aqeqeshe abanye abantu okanye obonelela ngeenkonzo zemfundo ezibandakanya unyango lweengcali eziqeqeshiweyo neenkonzo ezimalunga nendlela abantu abafunda ngayo ngokwenzeka kwinkqubo yokufunda nokuphucula iinkqubo zokufunda (*educational psychology services*), esikolweni ;

“umqeshwa” kuthetha —

- (a) utitshala ochazwe ngentla apha;
- (b) ilungu elingumsebenzi wasehostele;
- (c) ilungu elingumsebenzi wezolawulo;
- (d) ilungu elingumsebenzi onika inkxaso okanye umsebenzi okwimvumelwano oqeshwe ngokoMthetho i-Employment of Educators Act, 1998 (Act 76 of 1998); okanye ilungu elingumsebenzi onika inkxaso okanye umsebenzi okwimvumelwano oqeshwe ngokoMthetho weNkonzo kaRhulumente (IsiBhengezo 103 sika-1994) kunye/okanye oqeshwe libhunga lolawulo lesikolo;

“igosa lezobudlelane emsebenzini” kuthetha umqeshwa ovela kwiCandelo : lezoBudlelane eMsebenzini kwaNdlunkulu kwiSebe iWCED owenza umsebenzi wokuphanda isenzo sokuziphatha kakubi (*misconduct*) noqalisa iingxoxo ezimalunga nokuziphatha kakubi ngakumoni otyholwayo (*alleged offender*) oqeshwe liSebe leMfundo leNtshona Koloni (iSebe iWCED);

iyunithi i-“Family Violence, Child Protection and Sexual Offences (FCS) unit” kubhekisa kwiyunithi yeNkonzo yamaPolisa oMzantsi Afrika (*South African Police Service (SAPS)*) ejongene nokulwa izenzo zolwaphulo-mthetho ezinxulumene nezesondo (*sexual offences*) ngakubantwana, izenzo zolwaphulo-mthetho ezijolise ebantwini (*person-directed crimes*) (apho usapho luchaphazelekayo), ukususwa kwabantwana abangaphantsi kweminyaka

eyi-12 ubudala ngokungekho mthethweni nezenzo zolwaphulo-mthetho ezenziwa kusetyenziswa amajelo eendaba ngezixhobo zethekhnoloji (*electronic media*);

“ibhunga lolawulo” kuthetha iqumrhu elisemthethweni elithweswe umsebenzi wokuphatha isikolo sikarhulumente yaye linokwenza kuphela loo misebenzi nezo mbopheleleko zilolu hlobo yaye lisebenzise amalungelo alolu hlobo njengoko emiselwe nguMthetho weZikolo zaseMzantsi Afrika; 1996, (uMthetho 84 ka-1996);

“umenzakalo wokumbokrwa emzimbeni (*grievous bodily harm*)” kuthetha isenzo solwaphulo-mthetho esixhomisa amehlo esikukubangela ngenjongo nangokungenankathalo umonakalo emzimbeni womnye umntu;

“ungcungcuthekiso”, ngokoMthetho i-*Domestic Violence Act, 1998 (Act 116 of 1998)*, kuthetha—

(a) ngaphandle kwengqiqo—

- (i) ukulandela, ukubukela, ukuleqa okanye ukunkqangisa ngenkani ummangali okanye umntu ozalana naye; okanye
- (ii) ukuzulazula ngaphandle okanye kufutshane nesakhiwo okanye kwindawo apho ummangali okanye umntu ozalana naye, ahlala khona, asebenza khona, enza khona imicimbi yakhe, apho afunda khona okanye kwindawo ekwenzeka ukuba abekuyo,

nokuphembelela inkolelo esengqiqweni kummangali yokuba yena okanye umntu ozalana naye, unokwenzakaliswa okanye kunokonakaliswa iprophathi yabo;

(b) ngokuphindaphindayo, ukunxulumana nommangali ngokusebenzisa iinkonzo zonxibelelwano kusetyenziswa izixhobo zethekhnoloji (*an electronic communications service*), kungakhathaliseki nokuba ngaba—

- (i) ikhona okanye ayikho incoko; okanye
- (ii) kuhanjiswa nayiphi na ingcaciso kummangali;

(c) ukuthumela, ukuzisa okanye ukubangela ukuba kuziswe ngokuphindaphindayo, iipasile, imbalelwano kusetyenziswa izixhobo zethekhnoloji (*electronic mail*) okanye ezinye izinto kummangali, okanye ukuzishiya apho ziya kufunyanwa khona, zinikwe okanye ziziswe kuye ummangali ukwenzela ukuba aziqwalaselwe ummangali.

(d) ukufikelela okungagunyaziswanga kwimbalelwano yommangali okanye kwimbalelwano kusetyenziswa izixhobo zethekhnoloji yommangali;

(e) ukuzibeka esweni iintshukumo zommangali, imisebenzi okanye imibutho neendibano akuzo ummangali, ngaphandle kwemvume yommangali, kuqukwa, umzekelo, ngokusebenzisa izixhobo zethekhnoloji;

(f) ukungena kuyo nayiphi na inxenye yendawo yokuhlala eyindibanisela (*joint residence*) esetyenziswa ngokukodwa ngummangali okanye kwenye iprophati yommangali, ngaphandle kwemvume yommangali;

(g) ukuphazamisana ngokungekho ngqiqweni nayo nayiphi na iprophati esetyenziswa ngokukodwa ngummangali, okanye eyeyommangali;

(h) ukumxelela ummangali ngembalelwano kusetyenziswa izixhobo zethekhnoloji okanye ukubangela ummangali afumane imbalelwano,—

- (i) ehluke kumeyo, ethoba isidima, enentlamba okanye enyelisayo;
- (ii) emngcolisayo okanye emkhubekisayo ummangali ngokumalunga nesidima

- nesini sakhe; okanye
- (iii) ephembelela inkolelo kummangali yokuba yena okanye umntu ozalana naye unokwenzakaliswa okanye konakaliswe iprophati yabo; okanye
 - (i) ukuxela imbalelwano kusetyenziswa izixhobo zethekhnoloji, okanye ukwenza imbalelwano ifumaneka, komnye umntu malunga nommangali —
 - (i) equlethe ingcaciso eyeyabucala (*private nature*);
 - (ii) emngcolisayo okanye emkhubekisayo ummangali ngokumalunga nesidima nesini sakhe; okanye
 - (iii) ehluke kumezayo, ethoba isidima, ekhubekisayo okanye enyelisayo; okanye;
 - (iv) ephembelela inkolelo yokuba ummangali okanye umntu ozalana naye unokwenzakaliswa okanye kunokonakaliswa iprophati yakhe;

“ihostele” kuthetha indawo ekuhlala kuyo abafundi enxulumene nesikolo.

“iziko” kuthetha isikolo sikarhulumente esiqhelekileyo, isikolo semfundo eneemfuno ezizodwa okanye naliphi na iziko eliphantsi kolawulo lweSebe iWCED;

“ukoyikisa okunyanzelisa ukwenziwa kwesenzo esithile”, ngokwe-*Domestic Violence Act, 1998 (Act 116 of 1998)*, kuthetha —

- (a) ukwenzakaliswa ngokudlakatheliswa emzimbeni (*physical violence*), okanye umonakalo kwiprophati yommangali okanye yakhe nawuphi na umntu; okanye
- (b) izoyikiso eziyintsongelo yokwenzakaliswa ngokudlakatheliswa emzimbeni (*physical violence*), okanye ukonakaliswa kwepropati eyeyommangali, okanye eyomnye umntu;
- (c) ukumalela/ukumvimba ummangali okanye nawuphi omnye umntu ilungelo lakhe lenkululeko okanye ukumoyikisa ngokumsongela ukuba abe ngumntu okhululekileyo; okanye
- (d) ukuthumela isoyikiso esiyintsongelo, okanye ukubangela ukuba ummangali afumane isoyikiso esiyintsongelo (*threat*) (kuqukwa nembalelwano ethunyelwa ngezixhobo zethekhnoloji), nebangela ukuba umntu abe noloyiko lokwenzakaliswa ngokudlakatheliswa emzimbeni, okanye lokonakaliswa kwepropati yommngali okanye nawuphi omnye umntu eyeyakhe kusetyenziswa imbalelwano ethunyelwa ngezixhobo zethekhnoloji. (*electronic communication*), apho ukuziphatha okukolu hlobo kunenjongo yokumnyanzelisa ummangali ukuba akuphephe ukwenza nantoni na anelungelo lokuyenza ngokomthetho, okanye ukwenza nantoni na angaba nelungelo lokuba akuphephe ukuyenza ngokomthetho;

“umfundi” kuthetha nawuphi na umntu ofumana imfundo okanye ekunyanzelekileyo ukuba afumane imfundo ngokomthetho weZikolo zaseMzantsi Afrika ; (uMthetho 84 ka-1996)

“ixhoba elingumfundi” kuthetha umfundi/umntwana owenza isityholo sempatho-gadalala kubantwana kunye/okanye esokuxhatshazwa ngokwesondo ngakomnye umntu okanye umfundi/umntwana;

“ukungahoywa”, ngokumalunga nomntwana, kuthetha ukusilela ukwenza imisebenzi

eluxanduva yobuzali (*parental responsibilities*) yokunika umntwana iimfuno ezisisiseko zomzimba, zengqondo, ezeemvakalelo nezentlalo (*physical, intellectual, emotional or social needs*);

“umzali” ngokoMthetho i-South African Schools Act, 1996 (Act 84 of 1996) kuthetha—

- (a) umzali ozala/othathele kuye umntwana ukuze amkhulise okanye umgcini osemthethweni womfundi
- (b) umntu onelungelo ngokomthetho lokumgcina nokumnonophela umfundi, okanye
- (c) umntu ovumayo ukuphumeza iimfanelo zomntu ezichazwe kwimihlathana (a) no (b) ezimalunga nemfundo yomfundi;

“inqununu” kuthetha utitshala oqeshwe okanye obambe njengentloko yesikolo;

“isikolo” kuthetha isikolo sikarhulumente okanye isikolo esizimeleyo esibhalise abafundi ukususela kwiBakala R (*Reception*) ukuya ku-12;

“ikomiti yolawulo yesikolo” kuthetha ikomiti yolawulo yesikolo equlethe inqununu, usekela-nqununu neentloko zezifundo ezindima zazo zicaciswa njengezokuncedisa nokunika inkxaso inqununu ekulawuleni isikolo;

“ukuxhaphaza ngokwesondo” ngokoMthetho i-Children's Act, 2005 (Act 38 of 2005)], ngokunxulumene nomntwana kuthetha –

- (a) ukuhlukunyezwa ngokwesondo (*sexually molesting*) okanye ukwenzakaliswa komntwana ngokwesondo okanye ukuvumela umntwana ukuba axhatshazwe okanye enzakaliswe ngokwesondo;
- (b) ukukhuthaza, ukubangela okanye ukunyanzela umntwana ukuba asetyenziswe njengento eyanelisa omnye umntu ngokwesondo (*sexual gratification of another*);
- (c) ukusebenzisa umntwana okanye ukwenza ngabom ukuba abone izenzo zezesondo okanye imifanekiso yamanyala (*sexual activities or pornography*); okanye
- (d) ukuthenga okanye ukuvumela ukuba umntwana athengiselwe iinjongo zokuxhatshazwa ngokwesondo ngokushishina/ngokurhweba ngaye (*commercial sexual exploitation*) okanye nangayiphi na enye indlela yokuthatha inxaxheba okanye yokuncedisa ekuxhatshazweni komntwana ngokuthengiselwa iinjongo zokuxhatshazwa ngokwesondo .

“amatyala/izenzo zolwaphulo-mthetho zokuxhaphaza ngokwesondo” kuthetha amatyala/izenzo zolwaphulo-mthetho ngokubanzi nezeemeko ezikhethekileyo ezithile ezenziwa kubantwana nakubantu abakhubazeke ngokwasengqondweni (makujongwe isiHlomelo D ukufumana uluhlu lwala matyala/lwezi zenzo zolwaphulo-mthetho).

“amaZiko azii-Thuthuzela Care Centres” abhekisa kumaziko awenza zonke iinkonzo akwiindawo eziziifasilithi zokunonophela impilo (*healthcare facilities*) abonelela ngeenkonzo ezijolise kumaxhoba (*victim-centred services*) ngokwenza iinkonzo zophando zezonyango (*clinical forensic*), ezimalunga nemiba yezengqondo nezentlalo (*psychosocial*) nezinye iinkonzo ezichaphazelekayo ngeenkqubo ezibandakanya amacandelo amaninzi kumaxhoba obundlobongela obusekelwe kwisini;

“ukushishina/ukurhweba ngabantu (trafficking in persons)”, ngokoMthetho i-*Prevention and Combating of Trafficking in Persons Act, 2013 (Act 7 of 2013)*, ngokunxulumene nomntwana; kuthetha—

Nawuphi na umntu ozisa (*delivers*), ogaya (*recruits*), ohambisa (*transports*), othumela (*transfers*), ogcina (*harbours*), othengisa (*sells*), otshintshisa (*exchanges*), oqeshisa (*leases*) okanye ofumana omnye umntu apha ngaphakathi okanye ngaphaya kwemida yeRiphabliki yoMzantsi Afrika , ngokwenza oku –

- (a) isoyikiso esiyintsongelo sokwenzakalisa
- (b) isoyikiso esiyintsongelo sokusetyenziswa kwamandla (*force*) okanye ezinye iintlobo zeendlela zokunyanzelisa ukwenziwa kwezenzo ezithile ngomnye umntu
- (c) ukuxhatshazwa ngenxa yokuba usesichengeni, ungenakuzikhusela, unokuhlaselwa
- (d) ubuqhetseba
- (e) inkohliso
- (f) ukuthathwa ngogonyamelo komntwana ngaphandle kwemvume ngenjongo zokumxhaphaza (*abduction*)
- (g) ukuxhwilwa/ukuqweqwediswa;
- (h) ukusetyenziswa gwenxa kwamandla/kwamagunya

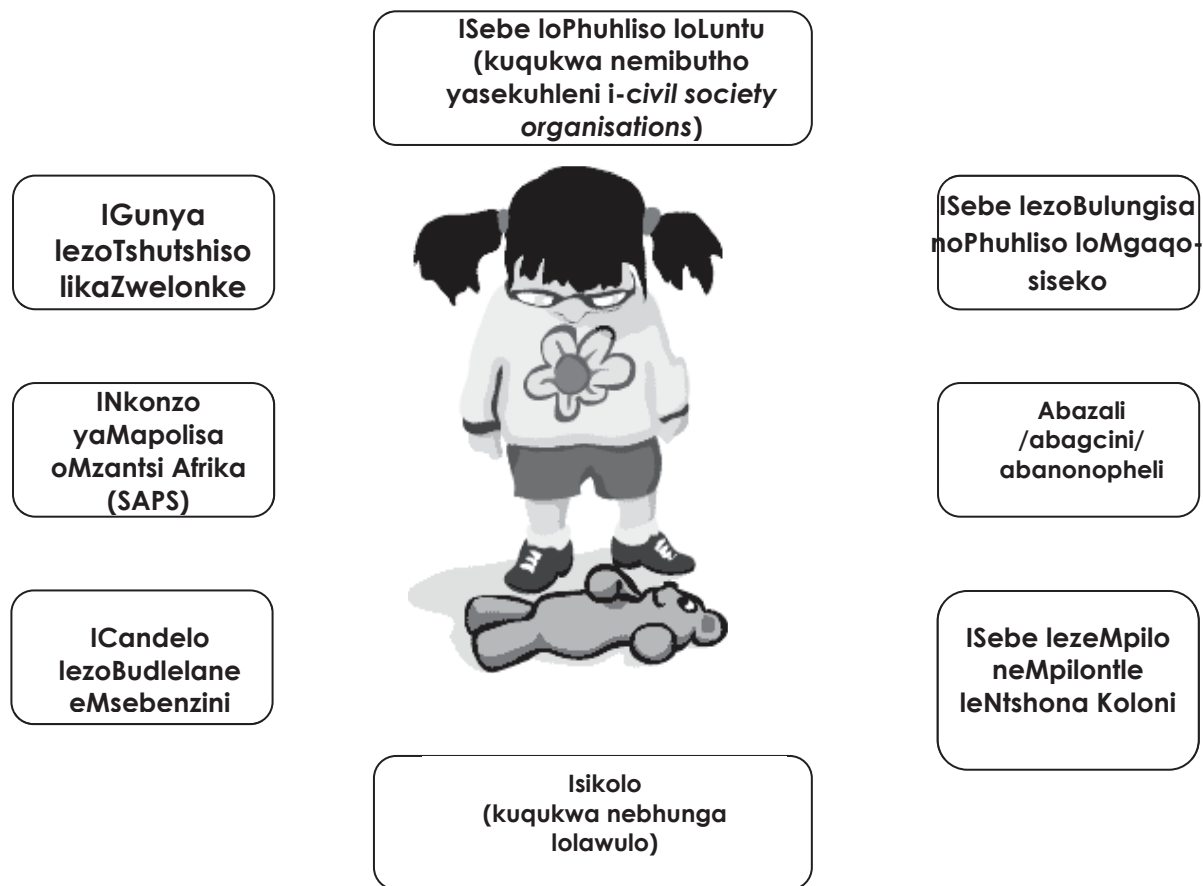
