1. Le setyhula imele ukufundwa kunye neSetyhula 0017/2022 *I-PYEI Phase III -Isikhokelo sezemali*, yomhla we-07 Apreli 2022.

**2. Isitayiphendi esihlawulwayo**

Isitayiphendi esiya kuhlawulwa kubo bonke abancedisi bezemfundo nabancedisi bezikolo jikelele kwiSigaba IV se-PYEI siya kuba yi-**R4 081,44** ngenyanga (nesingqinelaniswe nomvuzo ongowona usezantsi ngokomthetho omiselweyo), esiqala ngowe-01 Februwari 2023 yaye siphela ngowe-30 Septemba 2023. Ukongeza koku, iprojekthi iya kubonelela ngepesenti enye yentlawulo yomqeshi (*one percent employer contribution*), eya kuba yinxalenye yentlawulo eyenziwa ngomatshini eya kwisikolo sakho.

#### 4. I-Unemployment Insurance Fund (UIF)

Izikolo kufuneka ngokomthetho ukuba zibhalise kwi-Unemployment Insurance Fund (UIF) yaye zenze iintlawulo kwingxowa-mali yabancedisi abaqeshwe sisikolo. - UMthetho i-Unemployment Insurance Act, 2001 (Act 63 of 2001) kunye ne-Unemployment Insurance Contributions Act, 2002 (Act 4 of 2002) isebenza kuzo zonke izikolo (ukulungiselela le njongo yale projekthi ezithathwa njengomqeshi) kunye nabancedisi. Zonke izikolo KUFUNeka zihlawule isixa sentlawulo se-unemployment insurance ye-2% yexabiso lentlawulo yomncedisi ngamnye ngenyanga. Isikolo nomncedisi ngamnye banegalelo lentlawulo ye-1%. Isikolo (njengomqeshi) sinoxanduva lokuhlawula i-1% esiyitsalayo kubancedisi, kunye ne-1% njengoko ibonelelwe ngenkxaso-mali yeprojekthi yesahlulo somqeshi, kwi-UIF phambi komhla wesi-7 wenyanga nganye.

**8. Iintlawulo ezenziwa ngomatshini ukulungiselela ezinye iinjongo ezimalunga nale projekthi eziya kwisikolo sakho**

Abancedisi baya kufumana i-R30,00 zeenyanga ezisibhozo kuphela (ukususela ngoFebruwari kude kube ngoSeptemba 2023), ukunxibelelana nabaqeqeshi nokugqiba iimvavanyo emva kweyure zesikolo. Esi sibonelelo sinokuhlawulwa kubancedisi kunye nestayiphendi sabo saqho ngenyanga.

9. Makuqinisekiswa ukuba bonke abancedisi bayakuvuma ukusifumana nasiphi na isibonelelo esisodwa sakanye qwaba. Iikhontrolishithi (*control sheets*) ezilolu hlobo zimele ukuxela injongo yesibonelelo sakanye qwaba, iinkcukacha zomncedisi ngamnye (igama, ifani, inombolo yesazisi (ID)) kunye nesignitsha njengobungqina bokuvuma ukufunyanwa kwesibonelelo. Inqununu imele ukukusayinela oko kwikhontrolishithi njengobungqina bokugqibela bokugunyazisa ukuba zenziwe iintlawulo zabancedisi.

10. Iintlawulo ezenziwa ngomatshini ezongezeleweyo zinokwenziwa kwisikolo sakho ukulungiselela ezinye iinjongo ngethuba lokuqhutywa kweprojekthi. Naziphi na iintlawulo ezilolu hlobo ziya kwaziswa ezikolweni ngaphambi kokuba kwenziwe iintlawulo elolu hlobo.

**11. Iintlawulo zesitayiphendi ii-Pro-rata stipend payments**

Kubalulekile ukuqaphela ukuba nawuphi na umncedisi oqala enyangeni okanye olahlayo emsebenzini ngethuba lenyanga kuphela, ukufanele ukufumana isitayiphendi esingumlinganiselo welo thuba alisebenzileyo (*pro-rate stipend payment*). I-ofisi yale projekthi iya kuphonononga idatha yokuqeshwa nokulahla emsebenzini kwabancedisi njengoko ifakwa qho ngenyanga kwi-Data Management System (DMS). Kubalulekile ukuba izikolo zifake imihla yokuqeshwa nokulahla emsebenzini kwabancedisi ngokuchanekileyo nangexesha. Iinkqubo zeentlawulo zesitayiphendi zezikolo zisuselwa ngokumandla kumhla wokuqeshwa nokulahla emsebenzini njengoko ufakiwe kwikhompyutha zizikolo kwi-DMS.

12. Zonke iintlawulo ezingumlinganiselo welo thuba umqeshwa alisebenzileyo (*pro-rata payments*) zihlawulelwa iintsuku zekhalenda yaye ingezizo iintsuku zesikolo. Umzekelo ngulo: umncedisi olahlayo enkonzweni enyangeni, uya kufumana intlawulo engumlinganiselo welo thuba alisebenzileyo ngeentsuku zekhalenda azisebenzileyo ngenyanga yokulahla emsebenzini. Umncedisi onemvumelwano eqala ngomhla we-18 Agasti 2023, uya kufumana intlawulo yethuba alisebenzileyo ngo-Agasti yeentsuku zekhalenda eziyi-14 (18 Agasti ukuya kwi-31 Agasti 2023). Zonke iintlawulo zethuba elisetyenziweyo ziya kwenziwa ukususela ngethuba lokwenziwa kweentlawulo lokuqala elifumanekayo kwisikolo sakho (makufundwe umhlathi 7 apha ngentla ukwenzela imihla yeentlawulo ecwangcisiweyo). Izikolo zithwele uxanduva lokusebenzisa ezi ntlawulo zingumlinganiselo welo thuba lisetyenziweyo xa zihlawula abancedisi.

Isikolo simele ukuqinisekisa ukuba siyazitsala iimali eziyimfuneko kwiintlawulo ezingumlinganiselo welo thuba lisetyenziweyo ngokunjalo njengoko kucacisiwe apha ngentla ukwenzela abancedisi abangekhoyo nokuba ngabaphi na abarekhodiweyo esikolweni (umzekelo ikhefu elingahlawulelwayo), ezingqinelaniswe neemeko zenkonzo yengqesho njengoko zimiselwe kwimvumelwano yezengqesho. Nayiphi na intlawulo engaphezu kwemfuneko (*over-payments*) okanye iimali ezigcinwe sisikolo zimele ukubuyiselwa kwiSebe iWCED zingadlulanga iintsuku ezisixhenxe emva kwempela-nyanga nganye. Kucelwa kuthunyelwe nge-imeyili (umzekelo njengoko kuchaziwe kumhlathi 13 ngentla) ubungqina bentlawulo kwi-ofisi yeprojekthi.
