JOINT NOTICE OF THE WESTERN CAPE GOVERNMENT AND THE CITY OF CAPE TOWN METROPOLITAN MUNICIPALITY:

PROPOSED WITHDRAWAL OF THE PUBLIC ROAD PROCLAMATIONS AND CLASSIFICATIONS OF CERTAIN FORMER MAIN ROADS AND PORTIONS OF FORMER MAIN ROADS, IN THE AREA OF THE CITY OF CAPE TOWN METROPOLITAN MUNICIPALITY, AND PROPOSED DECLARATION OF THESE ROADS AND ROAD PORTIONS AS PUBLIC PLACES UNDER THE OWNERSHIP, RESPONSIBILITY AND AUTHORITY OF THE CITY OF CAPE TOWN METROPOLITAN MUNICIPALITY

- 1. I, Tertuis Simmers, the Provincial Minister of Infrastructure in the Western Cape Government, give notice of my intention under section section 3(2) of the Roads Ordinance, 1976 (Ordinance 19 of 1976) to:
 - 1.1. withdraw the public road proclamations and classifications of certain former main roads and portions of former main roads situated in the inner municipal area of the City of Cape Town Metropolitan Municipality, as described, and listed in schedules available for public inspection referred to in paragraph 3 below; and
- 2. I, Geordin Hill-Lewis, the Executive Mayor of the City of Cape Town Metropolitan Municipality, pursuant to section 1 of the said Municipality's Immovable Property By-Law, 2015 (*Provincial Gazette* 7544, dated 11 December 2015), give notice of the intention of the City of Cape Town Metropolitan Council to:
 - 2.1. declare the abovementioned former main roads and portions of former main roads to be "public places" as defined in section 1 of the said By-law where the public road proclamations and, where applicable, road classifications in respect of such roads and road portions have been withdrawn as contemplated in paragraph 1 above. These roads as contemplated in section 1 above, once deproclaimed, will function as designated arterials as defined in terms of the City's Outdoor Advertising By-Law, 2023 (*Provincial Gazette* 8969, dated 15 August 2024. Once these roads and road portions are declared to be "public places", the authority, responsibility, and ownership in respect of these roads and road portions will, in terms of section 2 of the City of Cape Town Metropolitan

Municipality's Immovable Property By-law, 2015 (*Provincial Gazette* 7544, dated 11 December 2015), vest in the City of Cape Town Metropolitan Municipality.

 - 3.3. In the foyer of the Department of Infrastructure located at 9 Dorp Street, Cape Town between 08:00 and 14:00 on business days; and at
 - 3.4. On the concourse level, 2nd Floor, Civic Centre, 12 Herzog Boulevard, Cape Town between 08:00 and 14:00 on business days.
- 4. The proposed decisions referred to above are intended to ensure that ownership, responsibility and authority in respect of the roads and road portions in question may be appropriately vested, in terms of section 2 of the City of Cape Town Metropolitan Municipality's Immovable Property By-law, 2015 (*Provincial Gazette* 7544, dated 11 December 2015), in the City of Cape Town Metropolitan Municipality, being the municipality having jurisdiction over the areas through which such roads pass.
- 5. The abovementioned proposed decisions are considered necessary after a consideration of the function of each road or road portion (as the case may be). The following considerations are relevant and have informed the above:
 - 5.1. The relevant former main roads, portions of former main roads have been identified by the Western Cape Government and the City of Cape Town Metropolitan Municipality for the purposes of the abovementioned proposed decisions after consideration of the following factors:
 - 5.1.1. Whether such roads and road portions qualify to be declared as "public places" in terms of section 1 of the City of Cape Town Metropolitan Municipality's Immovable Property By-Law, 2015 (*Provincial Gazette* 7544, dated 11 December 2015);

- 5.1.2. Whether such roads and road portions start and end within the municipal area of the City of Cape Town Metropolitan Municipality.
- 5.1.3. Whether such roads and road portions do not give passage to places that have substantial significance outside the City of Cape Town Metropolitan Municipality.
- 5.1.4. Whether such roads and road portions are not used for a purpose that has substantial significance outside the City of Cape Town Metropolitan Municipality; and/or
- 5.1.5. Whether the traffic on such roads and road portions does not have a material impact on traffic on the provincial road network.
- 5.2 The proposed decisions referred to above will not, if taken, adversely affect the primary purpose of these roads and road portions, as such roads and road portions will continue to exist and function as roads for public use under the responsibility, authority, and ownership of the City of Cape Town Metropolitan Municipality.
