1. PURPOSE


- 1.1 To request Departments to provide/report specific details on any problems and issues that are being experienced when dealing with SITA or when procuring IT goods and service through SITA.

2. DEVELOPMENT OF A PRO-FORMA ACCOUNTING OFFICER'S SYSTEM

- 2.1 It has been brought to the Provincial Treasury's attention that provincial departments are increasingly having problems in dealing with and procuring IT goods and services through SITA.
- 2.2 The matter (in consultation with CEi) has been escalated to the National Treasury which has requested that the consolidated problems of the Province providing specific details on issues, be submitted to them for investigation and further action.
- 2.4 For this purpose a template has been attached (Annexure A) for the capturing of departmental concerns / problems. The template provides for the minimum information that would be required to take this process forward. However should it not be sufficient feel free to expand the fields or attach any relevant documents or proof.

3. REQUEST

- 3.1 It is requested that departments disseminate the request to all relevant officials in their departments and provide feedback to this office by no later than **31 August 2010**.
