PUBLIC PRIVATE PARTNERSHIP FOUNDATION TRAINING FOR 2011

1. PURPOSE

The purpose of this circular is to share information about National Treasury's upcoming quarterly Public Private Partnership Foundation Training and to encourage provincial departments and municipalities to attend the PPP Foundation Training on the dates mentioned below.

2. BACKGROUND
