Please note that during the presentation at the induction sessions held, it was explained by the presenter to the attendees that Regulation 10 of the PPR 2022 repeals the 2017 Regulations in their entirety, including any designation circulars or instructions saved under the PPR 2017 in terms or regulation 16. In other words, the instructions and circulars issued in term of the PPR 2011 and PPR 2017 respectively, no longer have legal authority from the 16th of January 2023, except where they are used to evaluate a tender advertised before the effective date of the PPR 2022. Therefore, there will not be a formal communication as regulation 10 of the PPR 2022 is clear that it repeals the PPR 2017. We can confirm that a process is underway to remove all Designated Sector Circulars and Instructions from a list of active Circulars and Instructions so as to eliminate confusion.
