#### **PURPOSE OF CIRCULAR**

 This circular serves to inform municipalities that the Accounting Standards Board (ASB) will be presenting at the Accounting Working Committee (AWC) meeting to be held on Friday 31 May 2019.
 The invitation to attend this meeting is hereby extended to all municipalities within the Western Cape, even if they are not part of the Accounting Working Committee.

#### **OBJECTIVE OF ACCOUNTING WORKING COMMITTEE**

- 2. The objective of the AWC is to enhance the achievement of the objectives stated in Municipal Finance Management Act, 2003 (Act 56 of 2003) and the GRAP reporting framework. This is achieved by encouraging dialogue and debate between municipalities, Provincial Treasury and National Treasury, in order to establish both formal and informal communication channels as well as support networks.
- 3. The Committee aims to build institutional capacity and relationships by
  - a) facilitating and encouraging knowledge sharing;
  - b) promoting sound financial governance and accountability;
  - c) promoting the adoption of best practices;
  - d) Improve planning, co-ordination; and
  - e) prevent duplication of effort.

### **BACKGROUND INFORMATION**

- 4. At the previous AWC meeting held on Friday 22 February 2019, municipal officials requested that the ASB present at the next AWC meeting on matters that might assist municipalities when drafting the 30 June 2019 AFS.
- 5. In light of the above, it was determined prudent to extend the invitation regarding attendance of this meeting, to all municipalities within the Western Cape with a **maximum allowance of two representatives per municipality**.
