THE MUNICIPAL FINANCE MANAGEMENT INTERNSHIP PROGRAMME WORKSHOP

1. PURPOSE

To invite municipal finance management interns and internship champions from Western Cape Municipalities to the municipal internship workshop arranged by the Western Cape Provincial Treasury (WCPT) that will be held on **14 November 2023** via the MS Teams platform.

The purpose of the workshop is to provide guidance and share good practice to enable the effective implementation of the National Treasury Municipal Finance Management Internship Programme and to perform a verification process for municipal finance interns within the Western Cape.

2. BACKGROUND

Sections 5(3) and 34 of the MFMA mandates Provincial Treasuries to monitor, assist and support municipalities in building their financial management capacity and compliance with the MFMA and its related regulations.

The National Treasury (NT) Municipal Finance Management Internship Programme (MFMIP) was initiated in 2004 to assist municipalities to build their financial management capacity. The MFMIP is an organised professional and work experience programme with the goal of providing high quality training and practical exposure to interns in all aspects of municipal finance.

The WCPT monitors, supports, and assists municipalities within the Western Cape towards the effective implementation of the MFMIP and the achievement of its intended objectives.

3. OBJECTIVE OF THE WORKSHOP

The objective of the workshop is as follows:

- a) To provide a platform to communicate the strategic direction of the MFMIP programme, addressing challenges and sharing of good practices through interactive discussion and agreement on innovative, efficient, and effective solutions.
- b) To conduct a scheduled verification process on municipal finance interns within the Western Cape. The verification in compliance with the Guideline for implementation of MFMIP Guideline (2014), will cover the following areas:
 - i. Validity of contracts.
 - ii. Validity of formal qualifications of appointed interns.
 - iii. Documented work rotation plans.
 - iv. Formal training opportunities in line with the minimum competency levels.
 - v. Availability of mentors to support interns' development.
 - vi. Stipends payable to interns; and others.

It is imperative for NT to receive the correct data on all finance interns as the transferring department of the Financial Management Grant framework which funds the MFMIP. The correct data and performance information on finance interns will assist NT to plan, motivate and allocate for further disbursements of this grant in the Medium-Term Expenditure Framework period.

4. REQUIREMENTS OF MUNICIPALITIES

To enable effective implementation of the finance interns' verification, it is requested that municipalities email, by the **8 November 2023**, the following information:

- i. Valid contracts of all active finance interns:
- ii. Valid formal qualifications of appointed finance interns; and
- iii. Latest proof of stipend to finance interns. This could include bank notification of payment, deposit receipt or other acceptable proof of payment.

Municipalities are requested to submit the names and email addresses of the municipal interns and internship champions that will be attending the workshop by the **08 November 2023**.

Kindly submit to the respective relevant WCPT Contact person allocated for your Municipality as listed in the annexed Table 1. Once the online invitation has been sent, attendees are requested to accept the online invitation to confirm attendance. All financial interns and municipal intern champions are asked to attend the workshop.
