# LOCAL GOVERNMENT SCM INDABA: PREFERENTIAL PROCUREMENT AND THE IMPACT ON SUPPLY CHAIN MANAGEMENT AND LOCAL ECONOMIC DEVELOPMENT: 1 – 2 DECEMBER 2022, OVERBERG DISTRICT: THE DUNES – ARNISTON.

#### 1. PURPOSE

- 1.1 To inform all municipalities and municipal entities of the 5<sup>th</sup> Annual Local Government SCM Indaba: on the Preferential Procurement Regulations, that is scheduled to take place dated, 01 02 December 2022.
- 1.2 The SCM Indaba will be hosted in collaboration with the West Coast District, Central Karoo District, Cape Winelands District, Garden Route District and the Overberg District municipalities.
- 1.3 To request all municipalities and municipal entities to submit at least three (3) representatives, preferably the, SCM Manager, SCM Practitioner, SCM Accountant who will attend the Indaba.
- 1.4 A special request has been made to invite the District Municipality's Local Economic Development (LED) Manger of the five (5) District Municipalities to the SCM Indaba.
- 1.5 Where the senior official is unable to attend the Indaba the municipality and municipal entity may nominate a representative, preferably an official of the municipality's Supply Chain Management unit.

#### BACKGROUND

- 2.1 Following the Constitutional Court's judgment of 16 February 2022 on the matter between the Minister of Finance and Afribusiness regarding the 2017 Preferential Procurement Regulations (the 2017 Regulations), the Minister of Finance launched an application to the Constitutional Court seeking clarity on its judgement of 16 February 2022. Judgment was handed down by the Constitutional Court on 30 May 2022.
- 2.2 The SCA declared the entire Procurement Regulations invalid on the basis that the content of the Regulations exceeded the Minister's power on what could permissibly be regulated on in terms of section 5 of the Procurement Act and section 217 of the Constitution. The following areas were determined unconstitutional:
  - local content and production;
  - functionality;
  - subcontracting after the award of a tender;
  - cancellation of tenders;
  - prequalification for preferential procurement;
  - subcontracting as a condition; and
  - tender issuance of circulars and guidelines
- 2.3 Emanating from the Constitutional Court Judgment handed down dated 30 May 2022, in respect of the clarification sought by NT, confirmed that suspension of the declaration of the order of invalidity of the 2017 Preferential Procurement Regulations (PPR) is still valid for the remainder of the 12-month period, hence the 2017 Regulations are still in enforceable, until **26 January 2023.**

- 2.4 Municipalities are now required to put in place its own preferential procurement policy in terms of Section 2. (1) of the PPP Act. According to s217(2) of the Constitution, read with s2 of Procurement Act, organs of state must determine a preferential procurement policy, which states that "An organ of state must determine its preferential procurement policy and implement it within the following framework".
- 2.5 Taking cognisance of the above, the Provincial Treasury in partnership with the municipalities and municipal entities will drive the implementation strategy that has been put in place to assist municipalities with the implementation of the Preferential Procurement Policies. National Treasury subsequently gazette the final 2022, Preferential Procurement Regulations which take effect on 16 January 2023.
- 2.6 The **primary purpose** of the SCM Indaba is for the SCM fraternity to have a detailed discussion around the 2022, PPP Regulations and the PPP draft policies put forward by municipalities and Provincial Treasury for approval by each municipality's respective Municipal Council.
- 2.7 The Provincial Treasury also intends to use this opportunity to communicate to municipalities how to structure and develop the Preferential Procurement policies in line with Section 2 (1) (d) (i) and (ii) of the Preferential Procurement Policy Framework Act, 2000 which refers to specific goals which should be included in the policies:
  - (i) contracting with persons, or categories of persons, historically disadvantaged by unfair discrimination on the basis of race, gender or disability; and
  - (ii) implementing the programmes of the Reconstruction and Development Programme (RDP) as published in Government Gazette 16085 dated 23 November 1994.

## 3. OBJECTIVES TO BE ACHIEVED THROUGH THE SCM INDABA

- 3.1 Creating a "blue-print" Preferential Procurement Policy to be applied across all 30 municipalities which will encourage standardisation and uniformity.
- 3.2 Unpacking the use of strategic procurement as an instrument of local economic development.
- 3.3 To provide a socio-economic context for all 30 municipalities, which is imperative of the utilisation of procurement as a significant contributor to inclusive economic growth and development;
- 3.4 Through preferential procurement enhance strategic procurement to facilitate sustainable economic growth;
- 3.5 To promote, define and strengthen the supply chain management units;
- 3.6 To provide clarity and guidance on the Municipality's approach to procurement and local economic development, particularly with regards to the requirements of preferential procurement.
- 3.7 To effectively implement the Preferential Procurement Policy Framework Act, 2000 and its subsequent regulations issued in 2022, which to comes into effective on **16 January 2023**;
