# REQUEST FOR AUDITED ANNUAL RETURNS AND RELEVANT DATA-STRINGS FOR THE 2019 AFS VERIFICATION PROCESS

#### BACKGROUND

National Treasury utilises the financial information that has been uploaded on the NT LG Database for various publications, analysis and statistics. It is essential that this information is accurate and reconciles to the audited Annual Financial Statements (AFS) as presented to municipal councils. The AFS verification process ensures that the data uploaded by municipalities reconciles to the audited AFS of municipalities.

#### 2. PURPOSE

2.1 To request Western Cape municipalities to submit the following documents, in electronic format, to Provincial Treasury (PT): Local Government Accounting (LGA) by Friday, **20 December 2019**, for the process of AFS verification as required by National Treasury:

## 2018/19 Financial year

- BSA (Statement of Financial Position) audited annual return;
- OSAA (Statement of Financial Performance) audited annual return;
- CFAA (Cash Flow Statement) audited annual return;
- CAAA (Capital Acquisitions) audited annual return;
- AMA (Asset Management) audited annual return;
- ADA (Age Analysis of Debtors) audited annual return;
- ACA (Age Analysis of Creditors) audited annual return; and
- AUDA data-string (Audited data-string).

## 2017/18 Financial year (restated)

- BSA (Statement of Financial Position) audited annual return;
- OSAA (Statement of Financial Performance) audited annual return;
- CFAA (Cash Flow Statement) audited annual return;
- CAAA (Capital Acquisitions) audited annual return;
- AMA (Asset Management) audited annual return;
- ADA (Age Analysis of Debtors) audited annual return;
- ACA (Age Analysis of Creditors) audited annual return; and
- RAUD data-string (Restated audited data-string).
- 2.1 The AFS verification process requires LGA to verify the 2017/18 and 2018/19 AFS to the A1-Schedule reports, which is generated from the LG Database, based on the above submissions.
- 2.2 The LG Database is open for the submission of the relevant information as listed above.

### 3. MOTIVATION

- 3.1 The National Treasury requires the above information for various publication requirements.
- 3.2 To this end, it is critical that the municipality ensures that the information submitted agrees to the 2018/19 audited AFS.
- 3.3 To ensure the accuracy of information, the LGA unit is requesting that the relevant audited annual returns be submitted to your relevant LGA analyst for review, prior to submitting it to the LG Database. Thereafter the relevant A1-Schedule reports will be generated and compared to the 2018/19 audited AFS. Should any of the information not reconcile, the LGA analyst will communicate with the municipality to process the necessary adjustments to the submitted audited returns.
- 3.4 The verified information is required as inputs for the budget preparation process, as referred to in MFMA Budget Circular No. 98, therefore the AFS verification process should be concluded by **31 January 2020.**

#### 4. REQUEST

- 4.1 Municipalities are requested to submit the above-mentioned audited annual returns and datastrings for the 2017/18 (restated) and 2018/19 financial years by Friday, **20 December 2019**.
- 4.2 We would like to thank the municipalities that have already submitted the requested information to the LG Database. Your prompt response is much appreciated.
