# ADJUSTMENTS TO THE STANDARD CHART OF ACCOUNTS (SCOA) VERSION 5: CLASSIFICATION CIRCULAR (CC) 37

#### PURPOSE

- 1.1 The purpose of this circular is to inform departmental financial practitioners of the changes made to the Standard Chart of Accounts (SCOA COR 5 21 22 04) in the third quarter of 2021/22 financial year (1 April 2021 to 31 December 2021), issued 12 January 2022.
- 1.2 Amendments to the FUND segment have been aligned to the published Adjusted Appropriation Bill.

- 1.3 There were no changes made in the OBJECTIVE, RESPONSIBILTY, INFRASTRUCTURE and REGIONAL segments.

#### 2. ITEM SEGMENT

- 2.1 There were no changes made to the Compensation of employees, Assets, Liabilities& Equity and the Receipt segments.
- 2.2 The following new items were added under Goods & Services:
  - A&S/EDUCATION/GENL ASSISTANT (Agency & Support/Outsourced Services)
  - A&S/O/S: CLEANERS (Agency & Support/Outsourced Services)
  - CONS HOUS SUP: HABERDASHERY (Consumables Supplies: Household Supplies)
  - CONS HOUS SUP: BEAUTY PRODUCTS (Consumables Supplies: Household Supplies)
- 2.3 The following new items (non-pensionable allowances) were added under Purchase/Construction of Capital Assets:
  - NEW OFST:S&W: NON PENSION ALL RES (New Fixed structures, Own Account)
  - U&A OFST:S&W: NONPENSION ALL RES (Upgrade & Additions, Own Account)
- 2.4 Projects are either outsourced or undertaken on own-account. Outsourced projects are carried out by outside contractors and own-account project by government units.

#### 3. ASSET SEGMENT

- 3.1 A new category of assets under non-residential buildings has been added to cater for monuments and memorials that are not declared as heritage assets:
  - MONUMENTS AND MEMORIALS
