ADJUSTMENTS TO THE STANDARD CHART OF ACCOUNTS (SCOA) VERSION 5: CLASSIFICATION CIRCULAR (CC) 41

PURPOSE

- 1.1 The purpose of this circular is to inform departmental financial practitioners of the changes made to the Standard Chart of Accounts (SCOA COR 5 22 23 04) in the third quarter of the 2022/23 financial year (1 April 2022 to 31 December 2022), issued 31 December 2022.
- 1.2 There were no changes made to the RESPONSIBILTY, INFRASTRUCTURE and REGIONAL Segments.

1.3 The FUND Segment amendments have been aligned to the published Appropriation Act, 2022 and Division of Revenue Act, 2022 and distributed to the relevant departments.

1.4 The OBJECTIVE Segment amendments have been aligned to the published Estimates of National Expenditure (ENE) 2022 and the Estimates of Provincial Revenue and Expenditure (EPREs) 2022 and

distributed to the relevant departments.

2. **ITEM SEGMENT**

2.1 A new item named P/P: BODY CORPERATE LEVIES under the Goods & Services: Property Payments

category for levies paid to a body corporate has been **created**.

2.2 A new Receipt Item PASSPORTS (OFFICIAL) under Travel Documents category which is used to allocate the revenue received from passport issued to government officials who travel on official

business has been created.

2.3 The following two suspense Items: UNAUTHORISED EXP: DEPT VOTE:CA and UNAUTHORISED EXP:

STATUTORY:CA were removed from the Current Assets sub-category and created under Net Assets. These accounts control the amount of unauthorised expenditure that has been identified and

expensed against voted and statutory funds with or without funding, and the clearing thereof.

2.4 A new asset named ABLUTION FACILITIES has been added under the Non-Residential Buildings

category.

3. **REQUIRED**

3.1 Departments are requested to ensure that, where necessary, the PERSAL and BAS links are updated

to avoid PERSAL-BAS Interface exceptions.

3.2 Departments to take cognisance of the content of the SCOA Classification Circular No. 41 issued by

National Treasury.
