ORGANISATION AND STAFFING




For the financial year ending 31 March 2023, the vacancy rate was at 2.4 percent and the number of people employed by the Department stood at 2 464.

Our services are rendered through six Regional Offices, 45 local service delivery offices, 46 service points, and nine governmentowned facilities. We also partially fund more than 1 000 social service Non-Profit Organisations (NPOs) to who assist the most vulnerable in their communities.



AUDITED EXPENDITURE



Administration

The Department of Social Development has, for the 12th consecutive year, received a clean audit from the Auditor-General of South Africa.

This means that the Department's financial statements have been found to be free from material misstatements and that there are no material findings on reporting on performance objectives or non-compliance with legislation.

Social Welfare Services

Older Persons

18 787 vulnerable older persons made use of these services, of whom 13 119 accessed community-based care and support services such as service centres and clubs.

Persons with Disabilities

5 448 Persons with Disabilities and their families or caregivers accessed various services, of whom 1 033 beneficiaries accessed community-based day care centres.

Social Relief

4 189 families who experienced undue hardship and disasters were assessed and referred to SASSA for humanitarian relief. 27 817 boxes of sanitary pads were distributed to 302 schools benefitting female learners across the province.

Children and Families

Care and Services to Families

19 428 families accessed developmental social welfare services. 37 Shelters for homeless adults received funding, increasing in the number bed spaces from 2 028 in 2021/22 to 2 398 in 2022/23.



Child Care and Protection

3 966 children were placed in foster care, with a further 260 children reunified with their families or alternative caregivers. In addition, 3 339 parents and caregivers completed parent education and training programmes

Early Childhood Development (ECD) and Partial Care

120 After School Care (ASC) facilities were registered. Further, 6 397 children accessed services at funded ASC facilities which included homework and tutoring programmes as well as meals.

Child and Youth Care Centres

3 155 children at risk and in need of alternative care were placed in residential care facilities.

Community-Based Care Services for children

167 trained and qualified Auxiliary Child and Youth Care Workers supported registered Child and Youth Care Workers in providing development care.

Restorative Services

Crime Prevention and Support

A total of 11 197 children at risk participated in crime-prevention programmes across the province. In addition, 14 805 adults participated in diversion programmes.

Victim Empowerment Programme

26 DSD funded GBV shelters continued to provide therapeutic support to 2 369 women and their children who were victims of crime and violence, 24 388 victims of GBV accessed psychosocial support services across the province. One additional Thuthuzela Care Centre (TCC) was opened thereby increasing the number of TCCs to eight in the province.



Substance Abuse, Prevention and Rehabilitation

A total of 10 207 clients received substance use disorder services. In addition, 1400 learners accessed prevention and early intervention services through schoolbased programmes. Furthermore, 1921 clients accessed aftercare and reintegration services.

Development and Research

Institutional Capacity Building and Support

A total of 1 735 NPOs were assisted with registration, with an additional 1 021 NPOs capacitated to strengthen their governance and legislation compliance.

Poverty Alleviation and Sustainable Livelihoods

Over 109 300 qualifying beneficiaries accessed cooked meals and food parcels through departmental supported food relief interventions. A total of 1048 EPWP participants were provided with temporary work opportunities.



Youth Development

A total of 14 566 accessed youth to skills development programmes at funded Youth Cafés and community-based organisations. In addition, over 2 500 learners benefited from access to academic and life skills programmes.

Population Policy Promotion

The Department continued to support provincial and local government entities through training and capacity building sessions, to assist and inform planning and decision-making processes.
