# BILL

**To provide for the appropriation of money from the Provincial Revenue Fund for the requirements of the Province of the Western Cape in the 2007/08 financial year and to provide for subordinate matters incidental thereto.**

## PREAMBLE

**WHEREAS** section 226(2) of the Constitution of the Republic of South Africa, 1996 provides that money may be withdrawn from the Provincial Revenue Fund only in terms of an appropriation by a provincial Act;

**AND WHEREAS** section 26 of the Public Finance Management Act, 1999 (Act No. 1 of 1999) provides that the Provincial Legislature must appropriate money for each financial year for the requirements of the Province;

**AND WHEREAS** section 36 of the Municipal Finance Management Act, 2003 (Act No. 56 of 2003) provides that the Minister responsible for finance in the province, must to the extent possible, when tabling the provincial annual budget in the provincial legislature, make public particulars of any allocations due to each municipality in terms of that budget, including the amount to be transferred to the municipality during each of the next three financial years;

**B**E IT ENACTED by the Provincial Parliament of the Province of the Western Cape, as follows:—

## Definitions

**1.** In this Act, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Public Finance Management Act has the meaning assigned to it in that Act and— 5

“**Act**” includes the Schedules;

“**conditional grants**” means allocations to the province, from the national government’s share of revenue raised nationally, provided for in section 214(1)(c) of the Constitution of the Republic of South Africa, 1996; 10

“**current payments**” means any payments made by a provincial department in respect of the operational requirements of that department, and includes, amongst others, payments for the compensation of employees, goods and services, interest, rental of immovable property and financial transactions relating to assets and liabilities, but exclude transfers and subsidies and payments for capital assets; 15

“**Municipal Finance Management Act**” means the Municipal Finance Management Act, 2003 (Act No. 56 of 2003);

“**payments for capital assets**” means any payments made by a provincial department—

(a) for assets that can be used continuously or repeatedly in production for more than one year, and from which future economic benefits or service potential is expected to flow directly to the provincial department making the payment; and 20

(b) that must be classified as or deemed to be payments for capital assets in accordance with the *Reference Guide to the new Economic Format* 25

(November 2003, Version 2) and the *Asset Management Framework* (April 2004, Version 3.3), issued by the National Treasury under section 76 of the Public Finance Management Act;

“**Public Finance Management Act**” means the Public Finance Management Act, 1999 (Act No. 1 of 1999); and

“**transfers and subsidies**” means any payments made by a provincial department to another organ of state or any other person in respect of which the provincial department does not receive anything of similar value directly in return.

### **Appropriation of money for the requirements of the Province**

2. (1) Appropriations by the Provincial Parliament of money from the Provincial Revenue Fund for the requirements of the Province in the 2007/08 financial year, to votes and main divisions within a vote, and for the specific listed purposes, are set out in Schedule A. 10

(2) Subject to section 3, spending of appropriations is subject to the Public Finance Management Act. 15

### **Appropriation listed as specifically and exclusively**

3. Despite the provisions of any law, appropriations to a vote or main divisions within a vote that are listed as specifically and exclusively may only be utilised for the purpose indicated and may not be used for any other purpose, unless an Act of the Provincial Parliament amends or changes the purpose for which it was allocated. 20

### **Conditional allocations to municipalities**

4. Conditional allocations to municipalities from the provincial government’s budget in respect of the 2007/08 financial year are set out in Schedule B. An envisaged division of the conditional allocations to municipalities from the provincial government’s budget for the next financial year and the 2009/10 financial year, which is subject to the annual Division of Revenue Act for those years, is also set out in Schedule B. 25

### **Short title and commencement**

5. This Act is called the Western Cape Appropriation Act, 2007, and comes into operation on 1 April 2007.

**EXPLANATORY MEMORANDUM**

**WESTERN CAPE APPROPRIATION BILL**

The Bill provides for the appropriation of amounts of money to be withdrawn from the Provincial Revenue Fund in respect of the financial year ending 31 March 2008, for the requirements of the Provincial Government: Western Cape as per the Schedule A attached to the Bill.

Section 36 of the Municipal Finance Management Act, 2003 (Act No. 56 of 2003) provides that the Minister responsible for finance in the province, must to the extent possible, when tabling the provincial annual budget in the provincial legislature, make public particulars of any allocations due to each municipality in terms of that budget, including the amount to be transferred to the municipality during each of the next three financial years. This has been provided for in the attached Schedule B.
