

## Register of Contractors

- Only registered contractors may work for a Municipality
- Can be used for statistics
  - Numbers and Grades
  - Categories of work
- Future planning and alignment
  - Numbers of businesses in a Municipality
  - Size of companies
  - Comparison with IDP or planned work
- Developmental projects
  - PE Status
  - Other target areas, women, youth etc.





## Register of Projects

- All Municipal construction projects over
   R 200 000 must be captured on the RoP
  - Is used for statistics e.g.
    - Numbers and Grades
    - Categories of work
  - Developmental projects e.g.
    - PE Status
    - Other target areas, women, youth etc.

#### Two part process

- iTender Registration of project and tender advert via email or sms
- RoP Balance of project award, completion and deviations





The cidb was established to provide leadership to stakeholders and to stimulate sustainable growth, reform and improvement of the construction sector for effective delivery and the industry's enhanced role in the country's economy.

Media statement: cidb suspends contractors for fraud PDF

In a tough stance against fraud and corruption the Construction Industry Development Board (cidb) has suspended a number of unscrupulous contractors from its register since the start of its anti-corruption campaign last year. The suspensions effectively bar corrupt contractors from receiving government tenders for construction. Government departments, municipalities and public entities may not award tenders to contractors that are not registered with the cidb, according to the cidb Act 38 of 2000 and the Construction Industry Regulations of 2004.

cidb publishes list of blacklisted contractors PDF

Clients can now access on this website, the list of contractors who are suspended from the Register of Contractors for various offenses related to fraud. Acting on tip-offs via the anonymous hotline 0800 112 432 the cidb has intensified investigations into allegations of fraud and corruption. Investigations are followed by hearings and offenders are handed down a fine, suspension or both. Two of the cidb employees have already received dismissal and imprisonment following successful investigations into bribery and corruption allegations. The cidb has initiated an awareness campaign for contractors on fraud and corruption. Clients are also advised to remain vigilant against the use of suspended contractors.
